Failure to submit ALL local requirements within the allotted timeframe, may result in the closeout of your application with no further local action).

Concurrent to the above stated deadline, *local submissions are due by 12 noon the Tuesday three weeks prior to the committee meeting date to allow timely review.* Submissions received after the deadline will be scheduled for the next available committee meeting. NO EXCEPTIONS.
