The New Orleans Historic District Landmarks Commission's regularly scheduled meeting will take place on **Thursday, July 17, 2014, in the City Council Chamber, 1300 Perdido Street at 1:00 PM.** At this meeting public hearings may be heard on the following applications:

**The following items will be placed on the consent agenda:**

2275 Bayou Rd: Removal of rear porch addition, addition of a new screen porch in its place, ADA ramp and site fencing.

636 2Nd St: Renovation of existing building, including partial demolition of non-historic corner/side addition, reconstruction of front porch, and addition of side porch and fencing.

3304 St Claude Ave: Modification of single-story, mixed-use residential/commercial building; addition of camelback.

2713-2715 Laurel St: Construction of a two-story 2,000 sq. ft. single-family residence on existing vacant lot.

3116 Chippewa St: Partial demolition and two-story addition to rear of existing one-story residence.

1925-1927 Dauphine St: Construction of 600 sf rear addition.

3230 Camp St: Construct two-story, single-family residence on existing vacant lot.

**The following items will be placed on the regular agenda:**

210 State St: Landmark nomination of entire square bounded by Henry Clay Avenue, Tchoupitoulas Street, State Street and Leake Avenue, including all buildings and improvements.

1011 St Roch Ave: Demolition of existing building and construction of two-story, single-family residence with detached garage.

1200 Pauline St: Contemporary two story addition to a single family, Creole Cottage residential building.

3155 Dauphine St: Replace an existing slate roof with a new asphalt shingle roof.

2326 St Thomas St: Retention of rear porch enclosed without a CofA.

1302 Magazine St: Retention of windows installed in deviation of CofA.

611 Desire St: Retention of elevated side porch and rear, two-story camelback addition constructed without CofA.

800 Washington Ave: Retention of pair of 15-light doors and plexi-glass installed at front facade without a Certificate of Appropriateness.

1456 Camp St: Construction of an accessory building in the rear of the property.

5330 Dauphine St: Installation of solar panels in a visible location.

1125-1127 Delachaise St: Retention of demolition of existing one-story building and construction of two-story building. (scope change from renovation to new construction due to extent of demolition of existing one-story structure)

612-614 Olivier St: Retention of inappropriate metal handrails and guardrails installed without a Certificate of Appropriateness.

2332 Annunciation St: Retention of solar panels installed without a Certificate of Appropriateness.
