In December 2021, Davon Barbour was unanimously appointed President & CEO of the Downtown Development District of the City of New Orleans. He is an enthusiastic urban advocate, possessing more than twenty years of progressive leadership in inclusive economic and community development. His areas of expertise include public/private partnerships, retail revitalization, economic development, and community

development. He has worked for the private sector, public sector, and non-profit organizations revitalizing urban communities across the nation including Baltimore, Miami, Orlando, and Los Angeles.

Davon led the Community & Economic Development Division of the Los Angeles County Development Authority for where he oversaw the county's redevelopment initiatives, revolving loan portfolio, construction administration, and the nation's largest urban county district Community Development Block Grant (CDBG) program. He played a lead role in developing and administering more than \$150M in COVID-19 economic recovery programs such as business microgrants, loans and childcare. Additionally, Davon led the Downtown Partnership of Baltimore to win an Award of Excellence in economic development for "TechConnect", a business attraction program, from the International Downtown Association (IDA).

Davon has served in numerous volunteer leadership roles throughout his career. Locally, Davon is on the Board of Directors of UNITY for Greater New Orleans, a non-profit dedicated to ending homelessness. He is a member of the IDA Board of Directors and a former Vice Chair. Davon has been also extensively involved in ICSC where he currently serves on its Board of Trustees and is a past Western Division P3 Public Chair, past Eastern Division P3 Public Sector Chair, and former faculty member of its University of Shopping Centers. Davon has also contributed to advisory/technical panels for both the Urban Land Institute (ULI) and IDA.

With a career-long focus on improving historic neighborhoods of New Orleans and an extensive background in housing,-Kristin (and her husband Bobby) have personally invested in the neighborhoods of Algiers Point and Algiers Riverview for over 30 years.

Kristin believes in a comprehensive approach to neighborhood revitalization and has partnered with a number of local non-profits to work toward the greater goal of having a diverse and thriving community in Old Algiers.

"Housing should be affordable and accessible for all people with all income levels" With that in mind, Bargeboard has produced housing for every income level and every size from under 600 square feet to over 3,000 square feet. It has now expanded from a development company to also being a licensed contractor and operating a fully functioning millshop. The millshop allows Bargeboard to authentically produce millwork for historic properties and to produce unique cabinetry for its homes.

Kristin and Bobby's hard work has contributed to tremendous community improvement in these historic neighborhoods.

Bargeboard and the Palmers have renovated, built, or are in process of building & renovating more than 70 properties in Old Algiers, thereby putting these previously vacant and/or blighted properties back into commerce.

Kristin lives in Algiers Point with her husband, Bobby, their three daughters and a son- on the same block where they purchased and renovated their first home at the age of 24.

Working with the strong HPN membership, he helped establish several new cooperative business lines that contributed to the mission and economic goals of these organizations, and of HPN itself, including the National Community Stabilization Trust and the ReClaim Project, both focused on the recovery of distressed single-family assets. He was also instrumental in the founding of Develop Detroit and its predecessor model, the Gulf Coast Housing Partnership, to provide needed mission-driven real estate development and management capacity in highly distressed communities. Perrenod has overseen the development of more than 2000 affordable homes nationwide, including both rental and homes for sale, and the financing of nearly 15,000 others.
