

2016 Public Integrity Bureau Annual Report

PIB shall include in its annual report a summary of each misconduct complaint, including a description of the allegation, the final approved disposition, and any discipline imposed. PIB's annual report shall also include aggregate misconduct data showing the number of each type of complaint and the number and rate of sustained cases after final approval, and shall provide an analysis of this data that identifies trends and concerns and documents NOPD's response to the identified trends and concerns. The PIB and IPM should coordinate and confer with each other in collecting, analyzing, and reporting this data to avoid or minimize duplication of efforts or resources. [Consent Decree ¶426]

The Public Integrity Bureau (PIB), commanded by Deputy Superintendent Arlinda Westbrook, is responsible for the fair and consistent implementation of the disciplinary process, from the receipt of a complaint through its final resolution. This includes the assignment and processing of all disciplinary investigations, review of recommendations in all disciplinary investigations and hearings, maintenance of disciplinary records, and the coordination of specific investigations with outside agencies such as the Federal Bureau of Investigations and the Independent Police Monitor.

All bureaus and divisions are included in the disciplinary process. Although officers assigned to PIB investigate allegations of criminal misconduct against both police officers and civilian employees, the investigation of violations of administrative regulations are shared with first-line supervisors. In order to hold first-line supervisors accountable and ensure their involvement in complaints against their subordinates, many administrative complaints are forwarded to division commanders through their bureau chiefs for investigation. These investigations are reviewed through that bureau's chain of command, then ultimately by PIB and Superintendent of Police Michael Harrison.

The purpose of this report is to summarize misconduct complaint data collected for the past year, analyze that data, and identify trends and concerns in the areas of misconduct and discipline. This report identifies demographic information on the individuals that file complaints, as well as the officers that are accused of misconduct; the status and dispositions of misconduct investigations opened in 2016; the types of allegations filed against officers; and summaries of the alleged misconduct, as stated by the individuals filing the complaints.

To ensure the quality and integrity of the Department's compliant process, the Office of the Consent Decree Monitor (OCDM) routinely conducts bi-annual audits of NOPD misconduct investigations. In December 2017, the NOPD Compliance Bureau's Audit and Review Unit will also begin conducting supplemental audits on a more frequent basis. As an added accountability measure, PIB has also created an internal Quality Assurance Unit, including commissioned and civilian employees, focused on ensuring misconduct investigations handled by PIB and District investigators all maintain the same high standards set forth by the Department.

Key definitions

Complaint—Any allegation of misconduct committed by any NOPD employee that is reported by any person, including any NOPD employee.

DI-2 (Documentation of Counseling)—A DI-2 may be submitted when a supervisor becomes aware of an infraction committed by an officer, and the behavior is considered to be so minor that it is correctable by simple counseling or minimal intervention by a supervisor. The action taken must originate from a supervisor's knowledge of an employee's behavior which involves a minor administrative violation of a Departmental order, policy or procedure. The behavior must not severely impair or impact the efficiency of the public service, or the mission and goals of the Department.

Exonerated—The outcome of a disciplinary investigation in which a preponderance of the evidence demonstrated that the alleged misconduct occurred but did not violate NOPD policies, procedures, or training.

Formal Disciplinary Investigation—Internal New Orleans Police Department investigation that may result in disciplinary action as set forth in Civil Service Rules.

Misconduct—Any action or inaction that violates any Departmental Rule, Policy, Procedure, Order, verbal or written instruction, or criminal law.

No Formal Investigation Merited (NFIM)—A complaint action in which the allegation, on its face, does not constitute a violation by an employee of any Departmental Rule, Policy, Procedure, verbal or written instruction, or criminal or civil law.

Not Sustained— The outcome of a disciplinary investigation in which a preponderance of the evidence did not demonstrate that the alleged misconduct occurred.

Sustained— The outcome of a disciplinary investigation in which a preponderance of the evidence demonstrates the alleged misconduct occurred.

Unfounded—The outcome of a disciplinary investigation in which a preponderance of the evidence demonstrates the alleged misconduct did not occur or did not involve the accused officer or employee.

Relevant Policies

Chapter 26.2, “Adjudication of Misconduct,” became effective May 15, 2016, partially replacing Policy 1021. This chapter establishes procedures for conducting predisposition conferences and/or disciplinary hearings following internal investigations that identify potential misconduct and for the administration of penalties if allegations of misconduct are ultimately sustained.

Chapter 26.2.1, “Disciplinary Matrix / Penalty Schedule,” became effective May 15, 2016, also replacing portions of Policy 1021. This chapter provides penalty ranges for rule and policy violations. The disciplinary matrix delineates the lowest possible penalty, the presumptive penalty, and the maximum penalty for each level of offense.

Chapter 52.1.1, “Misconduct Complaint Intake and Investigation,” became effective on July 19, 2015, replacing former Policy 1020. This new policy, which governs the NOPD’s investigation of misconduct complaints, was approved by the Office of the Consent Decree Monitor (OCDM) and the Department of Justice (DOJ), and it is fully compliant with the Consent Decree.

Chapter 52.2, “Negotiated Settlement Agreements,” became effective November 15, 2015, replacing Policy 1023. The policy allows for resolution of misconduct complaints for minor violations reported by supervisors without a formal hearing. It was revised to allow for negotiated settlements involving body-worn camera violations. Chapter 35.1.7, “Non-Disciplinary Employee Counseling for Minor Violations,” was converted to chapter format; it became effective May 10, 2015. That policy allow for counseling or training as resolution of minor violations or infractions.

The Complaint Process

When a complaint is filed against a New Orleans police officer, the NOPD's Public Integrity Bureau conducts an investigation. Upon receiving a complaint, the Public Integrity Bureau reviews, classifies, and processes the complaint. An investigator may contact the complainant and obtain a recorded statement. The investigator will ask the complainant to provide as much detailed information as possible regarding the incident.


The investigator will contact all available witnesses, including police officers, examine all relevant evidence, and gather all information pertinent to each allegation. If for any reason there is a lengthy delay in the investigation, the complainant will be notified as to when he or she can expect to receive the results. After all allegations have been fully investigated, the Superintendent of Police will determine what action, if any, should be taken to resolve the complaint.

The investigation may result in several outcomes, depending on the final disposition of the complaint. If the disposition is exonerated, unfounded, or not sustained, no disciplinary action will be taken. In all cases, the person who made the complaint will be notified in writing of the investigator's findings.

When an allegation is sustained, the matter may proceed to a disciplinary hearing at which time a penalty will be recommended. The Superintendent of Police ultimately determines what penalty is appropriate. The penalty may range from a reprimand to suspension, fine, demotion, or dismissal from the department.

If the complaint includes allegations of criminal wrongdoing, a criminal investigation may be conducted in addition to any administrative investigation. The District Attorney may then be consulted regarding the filing of criminal charges and the possible arrest of the offending employee.

The following flow chart describes the misconduct complaint process:



Misconduct Complaint Findings

In 2016, the Public Integrity Bureau (PIB) processed 850 misconduct complaints, including 591 lodged by members of the public (70 percent of all complaints) and 259 that were initiated by other members of the NOPD (30 percent). The total number of complaints per year has decreased significantly over the last four years, even though 2015 and 2016 saw the same number of complaints (See Table 1). The NOPD does not believe that this decrease is related to access to the complaint process. Printed complaint forms are available in English, Spanish and Vietnamese at every police district station, NOPD Headquarters, PIB, and the Independent Police Monitor's office, as well as online.

Analysis of these data reveals several encouraging trends. For example, the total number of complaints had decreased for the last three years, prior to 2016, which equaled the previous year's total. In 2013, PIB received a total of 951 complaints; in 2016, it processed 11 percent fewer complaints. This downward trend occurs at a time when the New Orleans Police Department has bolstered community awareness of the misconduct complaint process through stronger outreach. For example, informational placards have been posted at every district station and police facility open to the public. These placards notify citizens in three different languages (English, Spanish, and Vietnamese) how to make a complaint against a police officer or Department employee, as well as how to file a commendation for excellent police work. The Department also created a detailed PowerPoint presentation for the public that explains the misconduct complaint process; the file is available on the NOPD Web site (visit <http://www.nola.gov/nopd/citizen-services/complaints/>).

Although several factors may have contributed to the downward trend, the Department believes fewer complaints suggest improved performance by NOPD officers in their law enforcement duties. The reforms and best practices implemented as a consequence of the federal Consent Decree have not only reaffirmed the Department's commitment to effective, constitutional policing, but are improving officers' relationship to the New Orleans community, including residents and non-residents.

The percentage of complaints initiated by the public versus other officers has fluctuated. In 2013, the number of rank-initiated complaints was 677 (or 71 percent of total complaints), in 2014 it dropped to 216 (25 percent), by 2015 the number was up to 301 (35 percent), and in 2016 it was back down at 259 rank-initiated complaints (30 percent). The hundreds of rank-initiated complaints

each year are primarily attributable to the Department's focus on accountability among NOPD staff, as well as revised disciplinary policies.

Although the Department is very focused on discipline, both as a function of command and as a means of public accountability, NOPD continues to explore alternatives to punishment in appropriate situations. For example, remedial training, redirection, and counseling can be effective ways to resolve minor administrative violations. In collaboration with the Independent Police Monitor, PIB attempted 41 successful mediations between complainants and accused officers in 2016, compared to 23 in 2015.

Summary of Complaints by Allegation

Whether Public or Rank Initiated, complaints may contain more than one allegation against an accused employee. Table 2 (following page) contains a summary of the of allegations over the last two years, by the Rule that was allegedly violated, the specific Paragraph/sub-section of the rule, and the count of how many of these specific allegations were made.

The overall results are promising. While there was the same number of complaints in 2015 and 2016, the number of overall allegations saw a significant decrease, from 1999 to 1821. The largest decrease occurred in allegations regarding Rule 4: Paragraph 2 "Instructions from an Authoritative Source," which dropped from 828 to 286 in a single year. On the other hand, some categories had significant increases as well. For example, alleged violations of Rule 4: Paragraph 4 "Neglect of Duty" grew from 418 in 2015, to 791 the following year. PIB attributes these and similar shifts in allegations to changes in NOPD's Disciplinary Matrix (Chapter 26.2.1), which was implemented in May 2016. Under the updated matrix, penalties that would have previously been considered "Instructions from an authoritative source," such as minor violations of written NOPD policies and/or directives, would now be adjudicated as Neglect. Now, "Instructions" typically applies to verbal commands.

Complaint Dispositions

The following table (Table 3) lists the number, and percent, of dispositions and statuses given by the end of calendar years 2015 and 2016. Sustained complaints dropped significantly between 2015 and 2016, not only as a total number (266 vs 199), but also as a percentage of total cases (32% vs 23%). While the “Sustained” disposition saw the greatest change, other dispositions in Table 3 indicate a shift in the overall dispositions applied by PIB.

Complaints by Demographics

The following tables describe the complaints filed against NOPD, organized by the demographic information (race/ethnicity, gender, and age/years of service) provided for both the complainants and the accused employees. Because the NOPD reporting software does not require input of complete employee demographics while completing reports, and some individuals involved in the complaint process choose not to provide identifying information, the data used below does have limitations. However, the following analysis is based on the most accurate information that could be pulled from the data provided.

The first group of tables below identifies the complainants, both public and rank, by the demographic information provided during the time they filed their complaint (Tables 4, 5 and 6). Table 4 shows that of all complainants that chose to identify their gender, 53 percent were women (313) and the other 47 percent (274) were men. However, there were 263 complainants that did not identify their gender; 216 of those that were not identified were members of the NOPD (Rank Initiated).

The following table (Table 5) indicates that complainants were far more likely to be Black or African American, than any other race/ethnicity. Of all complainants that identified their race/ethnicity, 395 (72 percent) identified themselves as Black or African American. Of all other complainants who chose to identify their race/ethnicity, the closest group was White or Caucasian complainants, with 133 (24 percent).

The following table (Table 6), captures the age ranges of those citizens who filed complaints. Rather than track the ages of complainants who are members of the NOPD, a comparable measure in relation would be the number of years they have served with the NOPD. However, that information is only captured on employees accused of misconduct (Table 8). Looking at public initiated complaints, it appears that about half are filed by individuals between the ages of 30 and 49; 204 (49 percent) of 414 complainants that listed a date of birth.

While each complaint is filed by individual complainants, multiple officers and/or NOPD staff can be named in a complaint. Because multiple people can be named in any given complaint, the number of “Accused” is higher than the number of individual complaints. While there were 850 complaints filed in 2016, the information found on NOPD’s open-data website (<http://nopdnews.com/transparency/policing-data/>) indicates that 1123 individuals were named in these complaints. Of those 1123, public initiated complaints were filed against 835 accused individuals, while rank initiated complaints were filed against 288 individuals.

The distribution of complaints across genders roughly follows the gender demographics of the department. While there were slightly more women that filed complaints than men, the vast majority of complaints are filed against male officers. Of the accused officers whose gender was identified, 793 (71 percent) were listed as male; compared to 203 (29 percent) listed as female (Table 7). These percentages appear to be closely linked to the demographics of the department, 75 percent male, 22 percent female, and about three percent that have no gender listed. There were 127 complaints in which the accused employee’s gender was not indicated.

Black or African American officers comprise 54 percent of NOPD and received 61 percent of complaints (Table 8). White or Caucasian officers received 337 complainants (34 percent) and represent 38.5 percent of the NOPD. 131 complaints did not contain a listed race/ethnicity of the accused.

The last of the demographic tables (Table 9) included in this report, describes the years of service of the NOPD employees accused in 2016 misconduct complaints. Table 9 shows that officers with fewer years of NOPD experience were far more likely to receive complaints. Specifically, of the rank initiated complaints, which indicated the accused officer’s years of service, 136 (48 percent) were filed against officers with 10 or fewer years with the NOPD. Similarly among public initiated complaints, 331 (48 percent) of the accused employees had 10 or fewer years with the NOPD. Table 9 also shows that 150 cases did not specify the accused employee’s years of service.

Misconduct Complaint Summaries

The following summaries describe all of the misconduct complaints lodged against NOPD officers and employees through the Public Integrity Bureau in 2016. The complaint process of the New Orleans Police Department is allegation-driven, and all allegations are taken seriously and investigated thoroughly. However, until a complaint is proven, allegations contained in the complaint have not been verified and should not be read as statements of fact.

Additionally, a “sustained” disposition does not necessarily indicate that the complainant’s allegations have been proven. Misconduct complaints often contain multiple allegations, and a “sustained” disposition reflects the fact that at least one allegation was proven to be true by a preponderance of the evidence. In some cases, an investigator may discover additional allegations that are not contained in the original complaint; therefore, a case may be given a “sustained” disposition even when none of the complainant’s allegations are proven.

Finally, a complaint may be given a “sustained” disposition when an investigation is completed, but that disposition may change once the complaint is adjudicated during a disciplinary hearing. The disposition of a complaint is not considered final until after the disciplinary hearing is held and the Superintendent of Police has approved the disposition and discipline. Consequently, the disposition of cases for which the discipline is listed as “Awaiting Hearing” or “Pending” may ultimately be changed.

Complainant states that officers took no action against individual who falsely accused complainant of brandishing a firearm at him.

Complainant stated he was stopped in his vehicle for no reason, handcuffed and arrested for violations he did not commit.

Complainant states that the accused officer used preferential treatment in disciplining a complaint operator that is also a relative.

Complainant (an employee) stated that over the New Year / Sugar Bowl weekend coverage supervisor showed favoritism while scheduling.

Complainant stated that supervisor has practiced favoritism in the department by allowing a relative to work overtime and denying request made by others to work overtime.

Complainant stated that he called 911 for individuals trespassing and unlawful entry on his property. The complainant stated to Sergeant that she felt disrespected by the officers because she called the police, but none of the officers who arrived on the scene spoke to her. The officer made her feel like she did not exist. The officer did speak with the owner of the property where she resides.

Complainant stated the officer stole his wallet and money.

Complainant stated the officer yanked a redirection from her hand and balled it up in front of other officers.

The complainant advised responding officers refused to take action when witnessing a physical altercation between her boyfriend and her nephew. It was further documented that one of the officers told the complainant to shut up because he was off duty.

The complainant stated he has a peace bond to have an ex-male friend stay away from him. The complainant stated that he saw two officers come out of a bar, intoxicated. The complainant stated that a friend told him that the ex-male friend and one of the officers were involved in the past in some type of relationship. So he went to his car and retrieved his gun and kept it on his side for protection. The complainant stated that the officer told him something very unprofessional, and also told him that he would be arrested when he approached him. The complainant stated that he left the scene and went home. The complainant stated that after leaving he had a voicemail from a Detective stating he wanted to speak to him. The complainant stated that he called the Detective several times and he left messages for him.

The complainant stated she contacted the police relative to domestic incident involving her daughter. The officer failed to exit the police unit and knock on her door.

Accused failed to properly supervise.

The officer who handled the incident only charged the subject with simple battery instead of aggravated battery. The complainant added she subpoenaed the records for the video footage in the station and received the response that there was no such recording. The complainant stated the outcome she wanted was for the officer to be reprimanded.

Complainant stated that Officer failed to arrest the perpetrator who violated a peace bond.

Complainant stated accused officer was not wearing a BWC, could not find reports in the EPR system and could not find a warrant.

The anonymous employee stated he/she went to CE&P and observed a civilian sitting in the office behind the desk in the technician area using the computer and talking with the NOPD employee. The complainant stated Police Recruit was assigned to Crime Lab and was not working her entire tour of duty. The supervisor was not supervising.

Complainant stated the accused neglected their duties in regards to monitoring Administrative Investigations.

The complainant left this complaint at the reception desk and immediately left the office. The complainant stated that the Officer was driving behind him and he came to a stop sign and then let her go in front of him. He stated the officer was still driving slowly and appeared to be texting on her phone so he went around her. The complainant stated that the officer pulled him over and stated with an attitude "You got somewhere to be?" The complainant stated that he was arrested and charged with careless driving, reckless operation, having no registration, and illegal lane change.

Complainant documented accused officer missed court.

Complainant stated a volunteer trainee with the NOPD Crisis Unit made sexually explicit comments towards a Crisis Unit Technician.

The complainant stated that she was not happy with the progress of the Detective's investigation into a missing person complaint and that the Detective was not working fast enough on the case.

Officer did not secure a departmentally issued Nikon camera in the trunk of her vehicle.

The complainant stated that Police Technician failed to report for duty and did not notify his immediate supervisor. Later he called and said he over slept. PTS arrived for duty late. Note this was the second incident.
