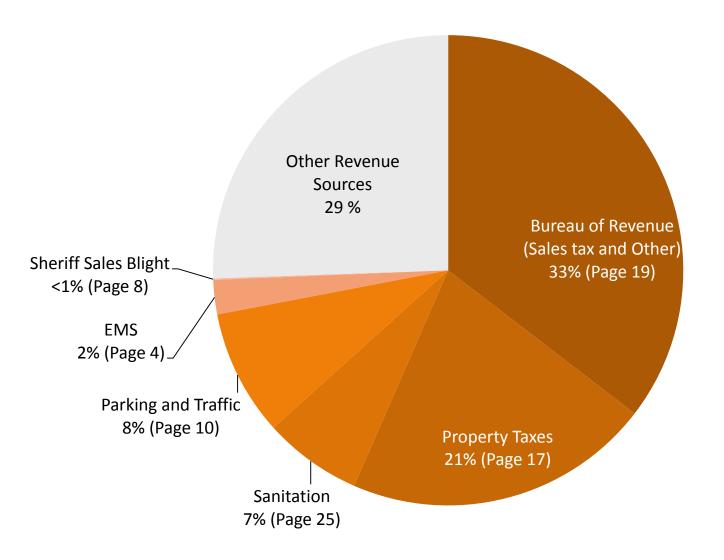

About BottomLineStat

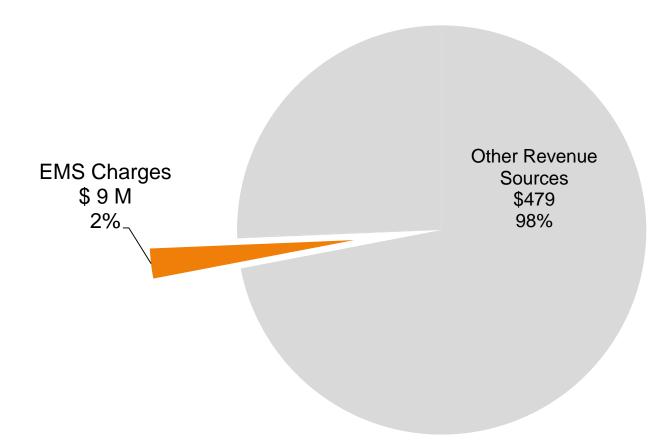
- BottomLineStat is a performance management system that The City of New Orleans uses to help manage the City's finances, to improve the efficiency of the city's revenue collection system, and to ensure that departments are held accountable for staying on budget
- BottomLineStat is a working meeting where key City staff review data to assess how the City is meeting its goals and to analyze what's working, what's not, and what the City needs to do to improve
- BottomLineStat is one of the PerformanceStats being implemented by the Office of Performance and Accountability, the team in charge of overseeing the City's performance management initiatives, like the ResultsNOLA performance reports

Revenue Source Analysis: Proportion of General Fund Revenues by Source

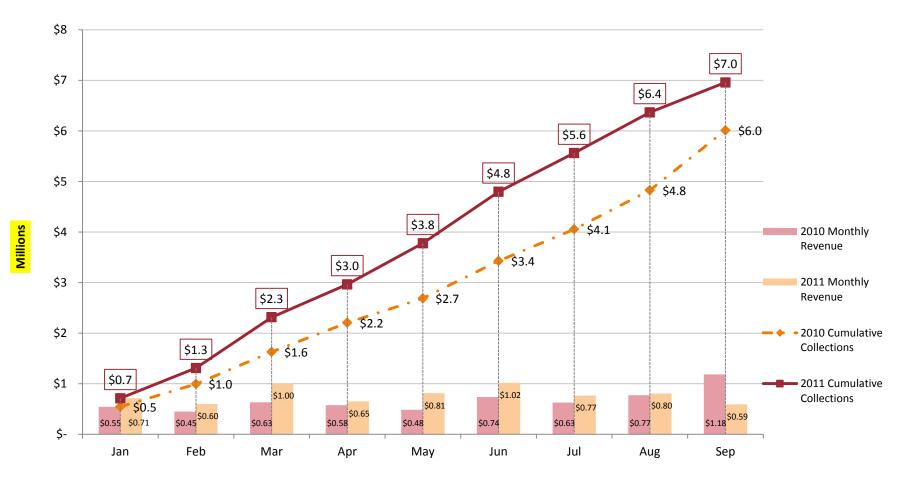
Budgeted Revenue of \$488 Million



Budgeted Revenues for 2011 : EMS Charges 2% of GF Revenues



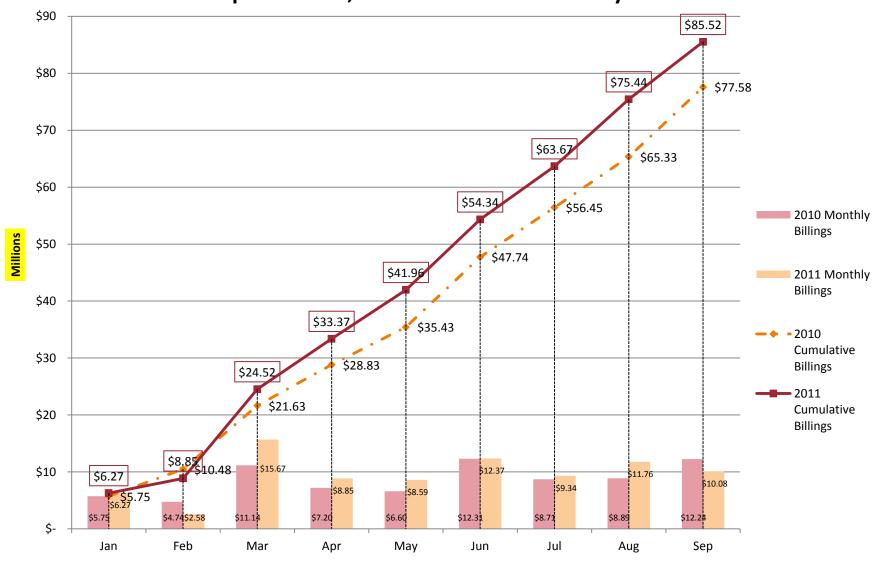
EMS: YTD Revenue Collected for All Payer Types as of September 30, 2011 Exceeds Prior Year by 16%

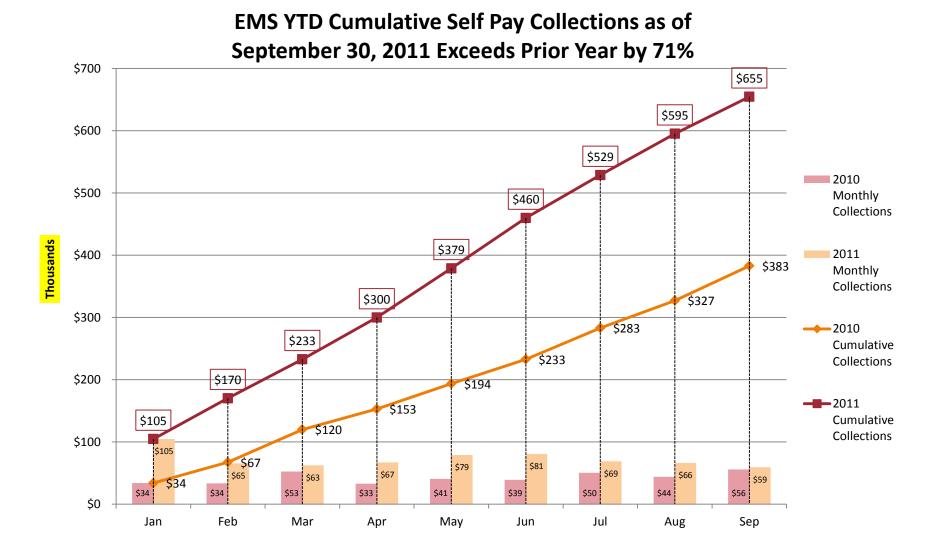

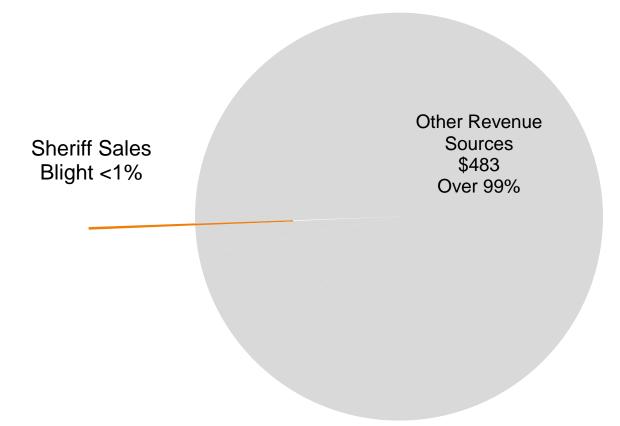
EMS: YTD Cumulative Self Pay Billings as of September 30, 2011 Exceeds Prior Year by 10%



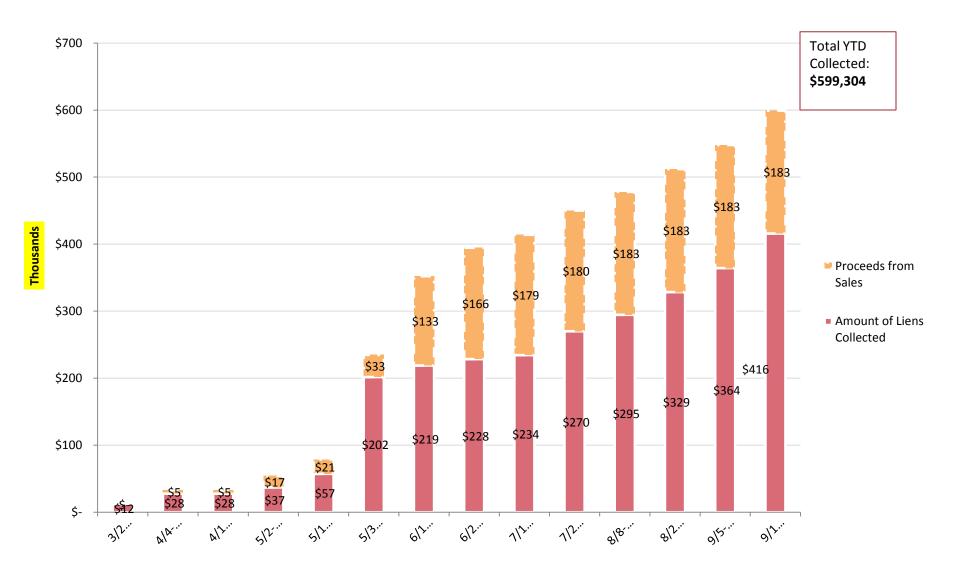

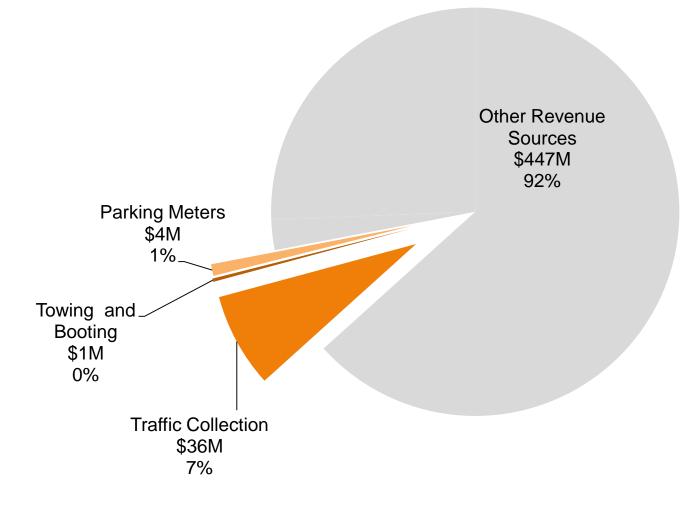
Budgeted Revenues for 2011 : Lien Foreclosures less than 1% of GF Revenues



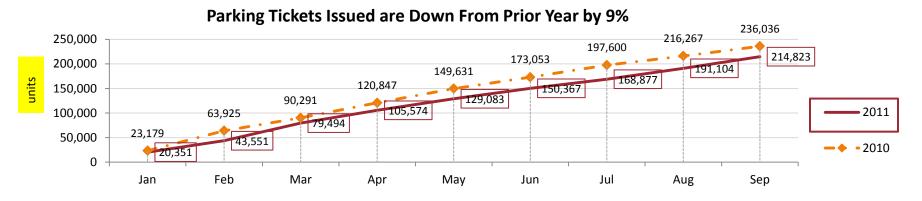
Blight Process: Bi-weekly Revenues Collected from Code Lien Foreclosure Process as of September 30, 2011



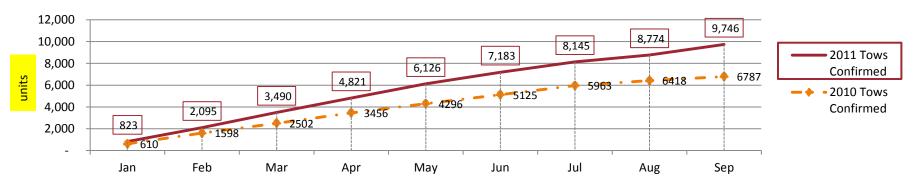
Budgeted Revenues for 2011 : Parking and Traffic Revenues 8% of GF Revenues



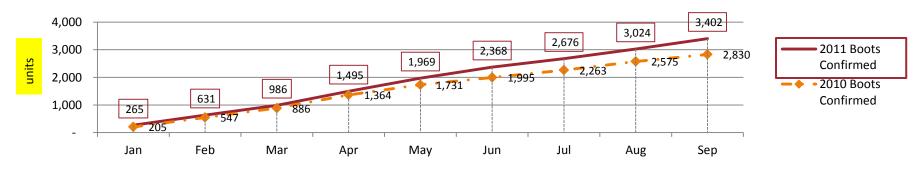
Parking : Counts of Parking Violations by Type



Cumulative Towing Activity Exceed Prior Year by 44%

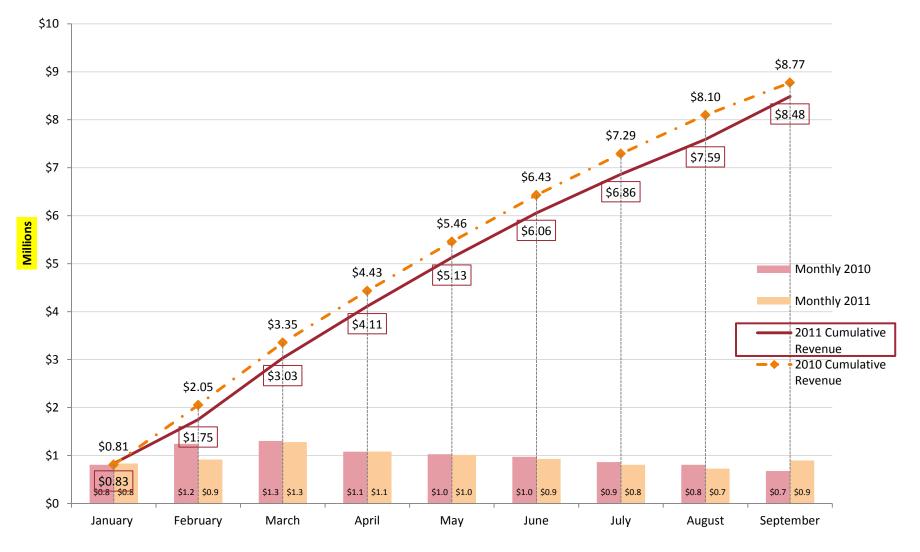


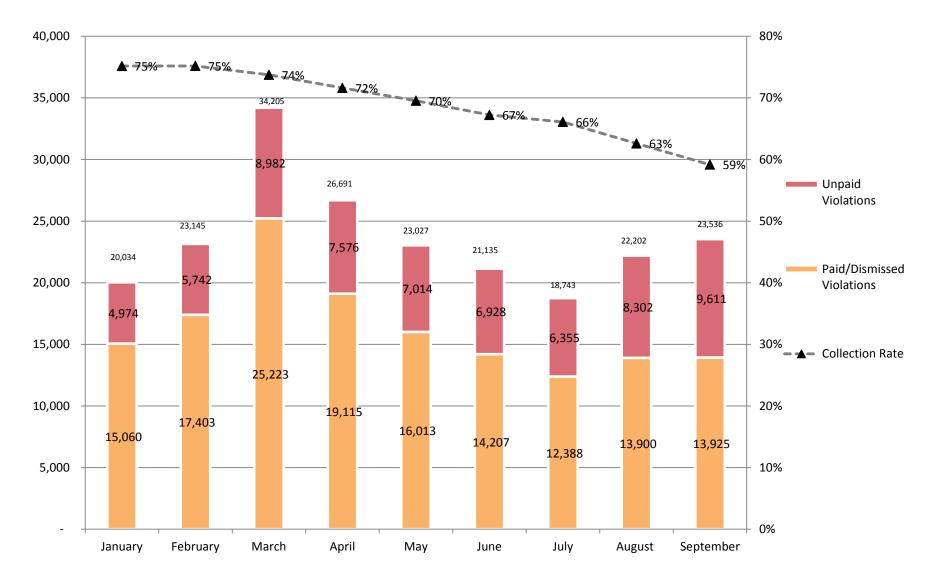
Cumulative Booting Activity Exceed Prior Year by 20%

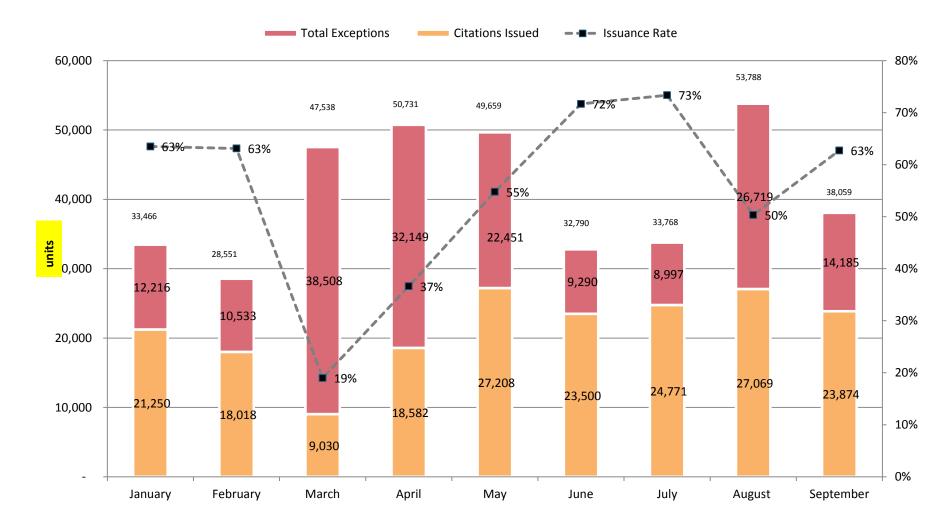
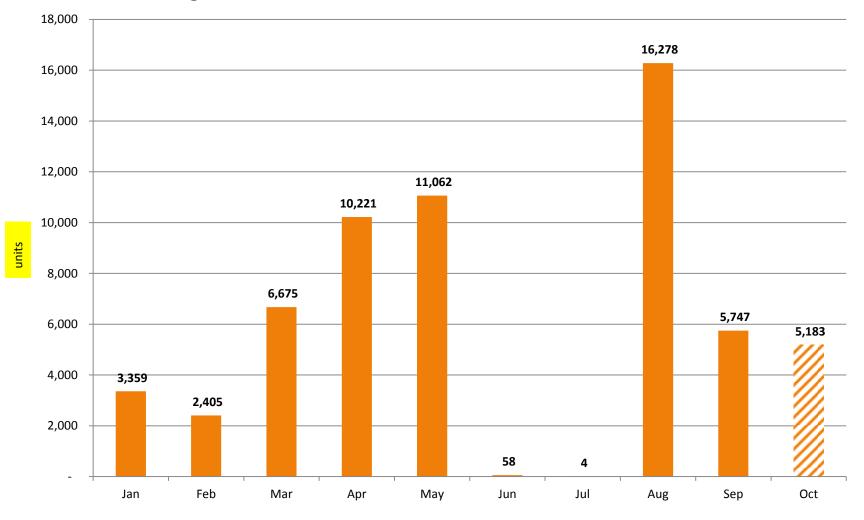
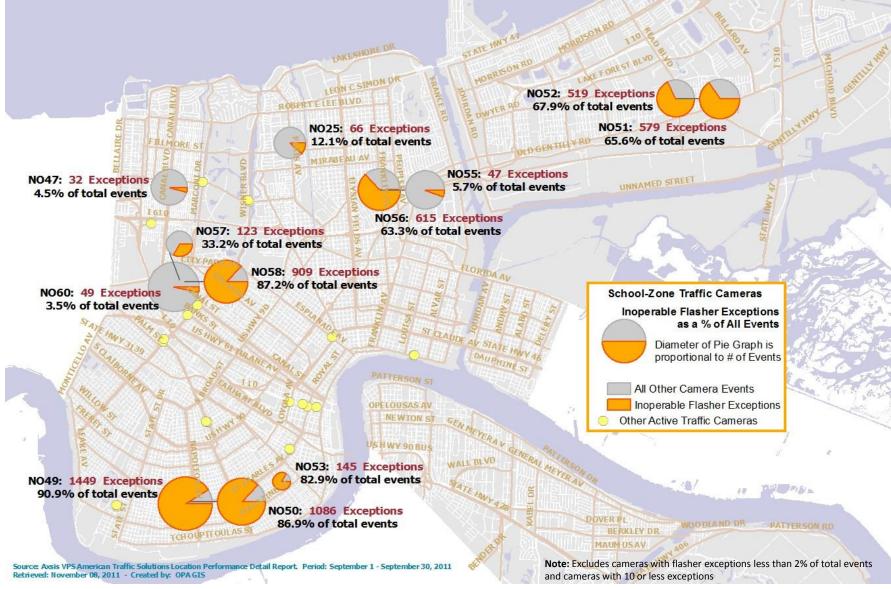


Photo Safety: Monthly Exceptions Issued for Flashers Inoperable During School Zone Enforceable Time as of October 31, 2011

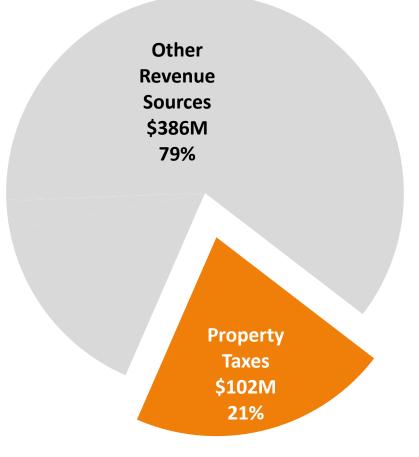

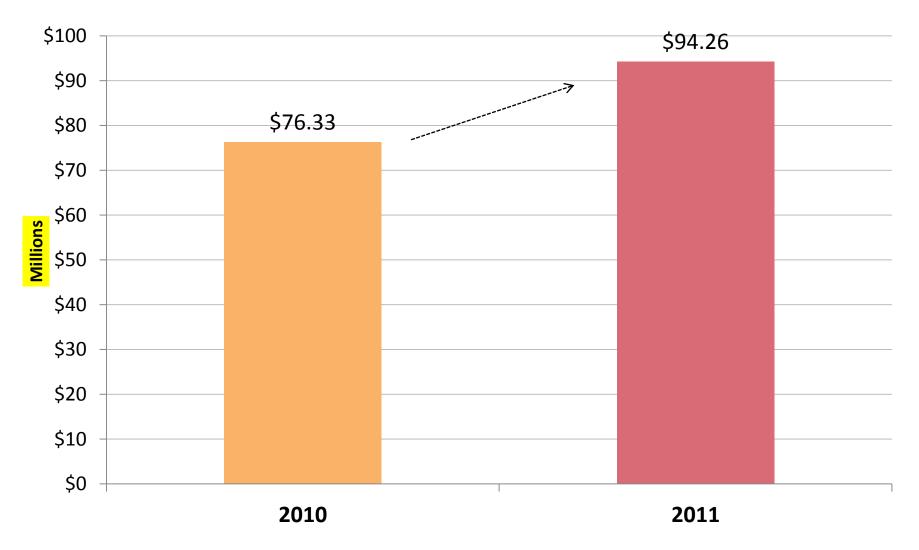
Location ID of Cameras Responsible for 5,747 Inoperable Flasher Exceptions for the Month Ended September 30, 2011.



Budgeted Revenues for 2011 : Property Taxes 21% of GF Revenues



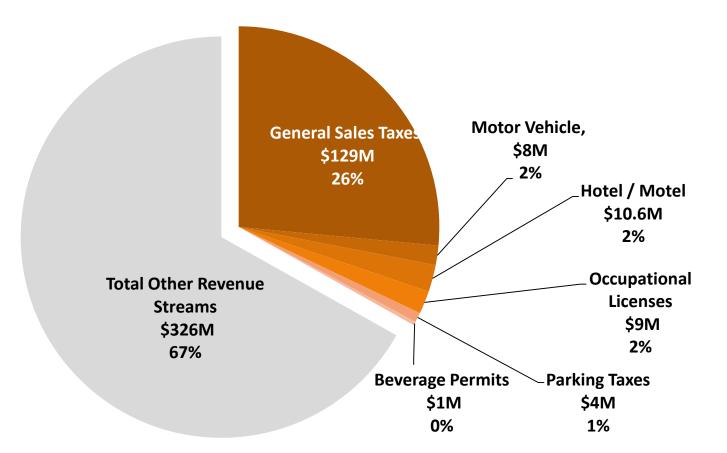
Property Taxes: Millage Rollforward results in 23 % increase in Cumulative <u>YTD</u> Collections As of September 30

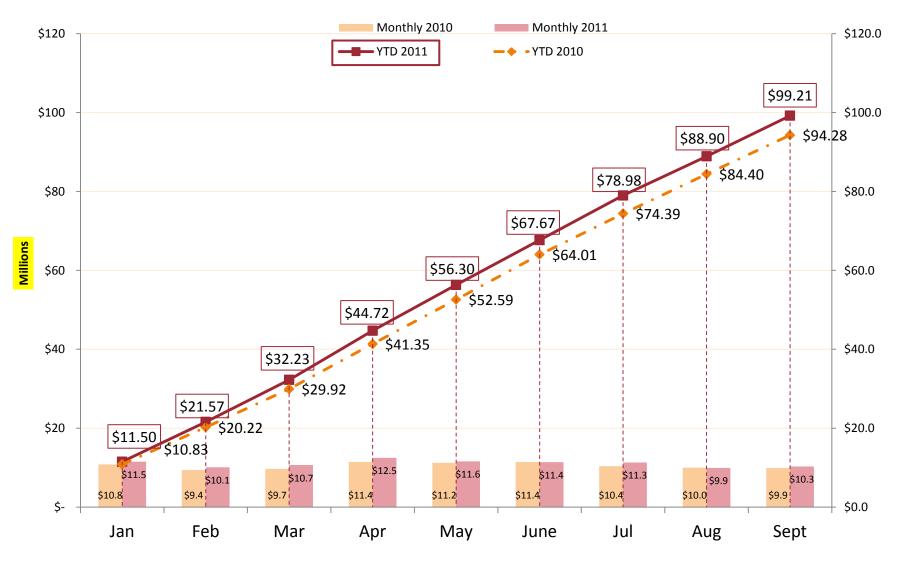

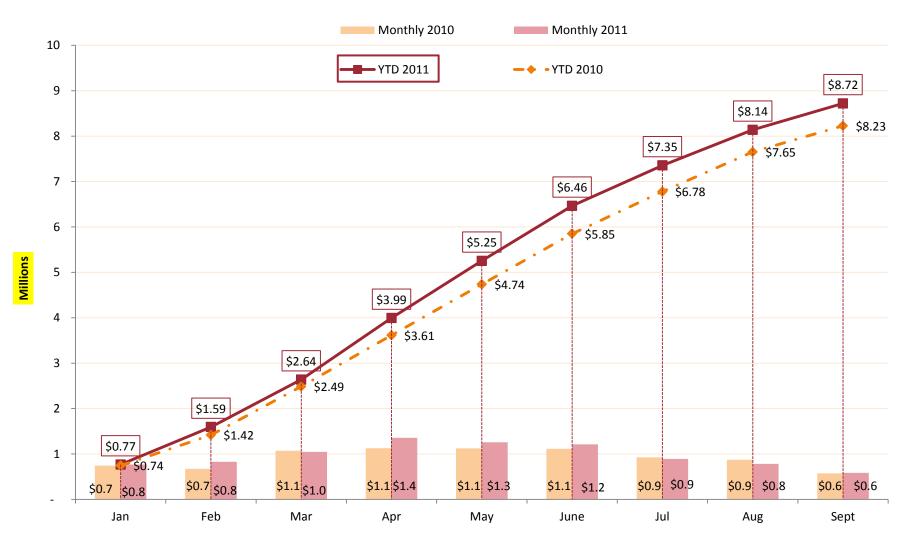

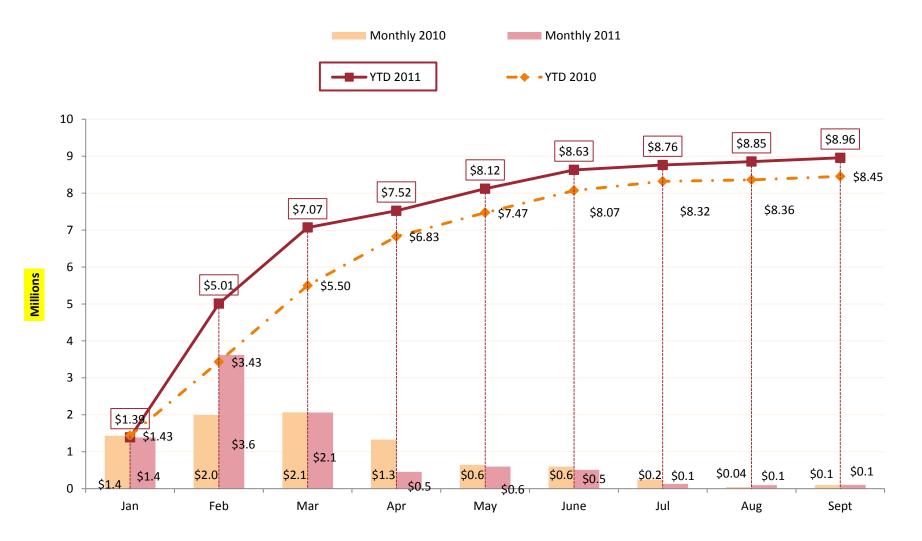

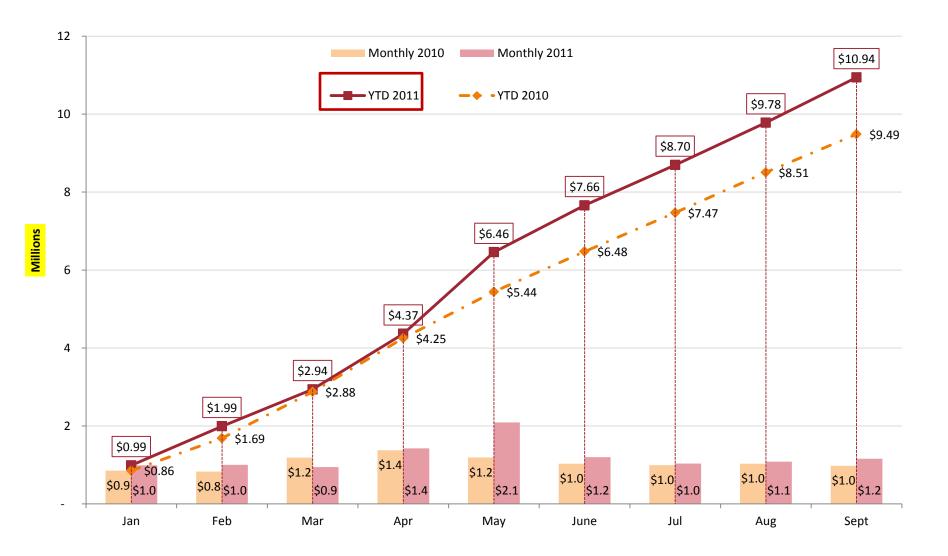
Hotel/Motel Sales Taxes: Cumulative <u>Collections</u> as of September 30, 2011 are up 6% in 2011 vs. 2010



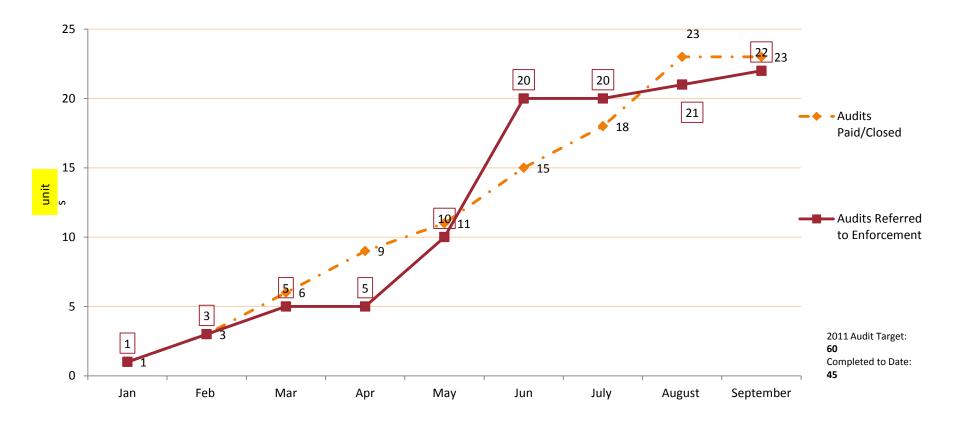
Occupational Licenses Revenue: Cumulative <u>Collections</u> as of September 30, 2011 are up 6% in 2011 vs. 2010



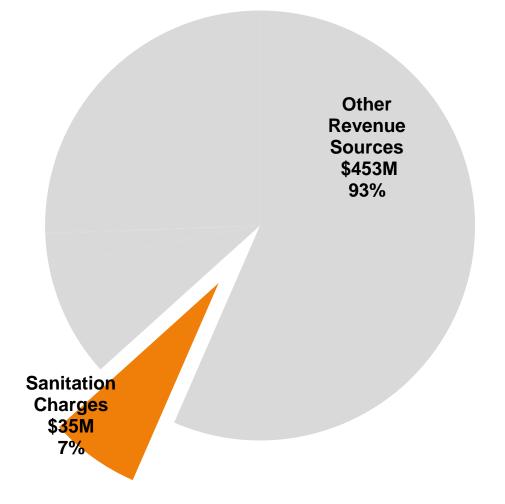
