- Applicant's Birth Certificate or Birth Card
- Current Applicant's ID: (2023–2024) School ID, State ID, or Driver's License
- ✓ Applicant's Social Security Card



- Applicant's Most Recent Report Card or Progress Report
- Proof of Address: (Lease, Utility Bill, or Voter's Registration Card)
- Proof of Income (College interns ONLY): (All income in the last 30 days (No W-2) FITAP Letter, SNAP, Child Support Printout, Social Security Printout(s), or College award letter)
- Proof of Guardianship ID: (name must be on the child's birth certificate or must provide legal proof of guardianship)
- Parent/Guardian ID (if you are under 18)
- Proof of Selective Service Enrollment (males ages 18–24)
