PRESENTATION

Annual Actuarial Valuation Report - Segal Consulting - Jeff Williams

Mr. Williams presented the annual actuarial valuation for January 1, 2020. He reviewed the assumption changes that were a part of the valuation. Additionally, a year to year comparison was reviewed to show the impact of the changes and result of the 2019 investment performance. The board discussed the funding ratios based on market value of assets and actuarial value of assets.

2021 Annual Required Contribution Rate

She discussed the fees of the portfolios and the historical performance of the City of New Orleans investment. Additional details related to annual fees compared to year over year performance for the City of New Orleans investment was requested. Ms. Vella discussed the process of investing additional funds in the Millennium fund.

Mr. Jones discussed the YTD market environment. In addition to the market environment and June 30, 2020 performance report, he discussed the variance in returns between growth and value and the performance of the international and emerging markets. He further discussed the fixed income market and the historically low return of the Barclays Aggregate Bond Index.
