ROLL CALL Mr. Block called roll. Ms. Gasperecz, Mr. Fifield, Ms. DiMaggio, Mr. Bergeron,

Mr. Villarreal and Ms. King were present. [Dr. Reeves arrived during the

presentation of 429 Decatur]

REVIEW OF MINUTESMs. Gasperecz noted that staff requested deferral of the minutes and

ratification of staff and Committee actions prior to the meeting. Mr. Villarreal noted that the meeting minutes for the March VCC meeting noted him as absent and that he had attended the meeting but had technical difficulties and

was unable to speak.

CHAIRPERSON'S REPORT Ms. Gasperecz noted the increased size of recent meeting agendas and took

the opportunity to thank the Architectural Committee and VCC staff.

DIRECTOR'S REPORT Mr. Block announced that the VCC staff had moved back into City Hall following

vaccination for Covid-19. He stated that meetings with staff would still be by

appointment only for the immediate future.

Mr. Block explained the format for today's meeting. He stated that each plans examiner would read their respective reports and the floor would be opened for public comment prior to motions by the Commission. Any public comment received by email during the 30-minute recess would be read into

the record.

I. NEW BUSINESS

429 Decatur St: 21-05094-VCSGN; Michael Barr, applicant; Kara Farms LLC, owner;

Ms. Vogt read the staff report with Ms. Hurst and Mr. Latter present on behalf of the application. Mr. Latter stated that the sign company was working on revising the drawings following Architecture

Committee review. Ms. DiMaggio noted that the installed location would be different than the historic sign since it was on a different building, asking if this would be a problem. Mr. Block stated that the designation was more about the replicated sign, not the position of the installation, noting that he believed the regulations allowed some leeway in this area. Mr. Bergeron asked the applicant if they had access to the historic sign to be able to faithfully reproduce it; Mr. Latter responded yes, that they had measured the sign and had access to it until the end of the month. Mr. Block noted that the drawings would be reviewed by the Committee, and the Commission was only reviewing the proposed classic sign designation. Dr. Reeves stated that he wished they could relocate the original sign; Mr. Latter agreed, regretting that the matter was complication and relocation was not an option. With nothing left to discuss, the Commission moved on to the next agenda item.

Ms. Vogt read the staff report with Ms. Kelso present on behalf of the application. Ms. Kelso requested a deferral as Ms. Weber, the applicant, had a medical emergency. With no discussion needed at this hearing, the Commission moved to the next item on the agenda.

Mr. Albrecht read the staff report with Mr. Jenkins present on behalf of the application. Mr. Jenkins stated that he had misunderstood the original ARC motion of conceptual approval and thought this meant full approval. He went on to say at that point they had the doors made and installed them. Mr. Jenkins then explained that the proportions on the inside were different than the outside. He went on to say that if they had to change the doors, they would have to be rebuilt from scratch, so they had come to the Commission with a hardship claim. Ms. Gasperecz asked if there were any comments or questions on the part of the Commission. With no questions or comments, the Commission went to a 30-minute recess for public comment.

Mr. Bergeron made the motion for a 30-minute recess for public comment. Dr. Reeves seconded the motion and the motion passed unanimously. The Commission was to reconvene at 1:52PM.

Following the 30-minute recess, Mr. Fifield moved to resume the meeting. Dr. Reeves seconded the motion and the Commission voted unanimously to resume at approximately 1:53PM.

Discussion and Motion:

Mr. Latter stated that he was unsure if the other property owner would seek classic sign designation but that they could not retain the name on the sign. For clarification, Ms. Vogt stated that the original sign at 823 Decatur was not on the agenda and would not meet the criteria for a classic sign if altered. Mr. Fifield made the motion for **approval** of the classic sign designation in accordance with Section 24.15.A(2)(a). of the CZO. Ms. DiMaggio seconded the motion. Dr. Reeves stated that the motion needed to specify that the new sign would match existing exactly; Mr. Block stated that this was implied, as the new sign would be non-conforming and could not be built without being an exact replica per the CZO. The vote was called and the motion passed unanimously.
