ORDER

The Commission heard this matter at its March 3, 2023, regular meeting. The Sewerage & Water Board moved for dismissal of this appeal. Pursuant to La. C.C.P. art. 2126(E)(1), because Mr. Woods failed to pay the estimated costs before February 15, 2023, Mr. Woods abandoned the appeal, and the appeal is dismissed.

Mr. Woods requested an appeal on October 11, 2022. The Commission granted this appeal. On January 26, 2023, in accordance with La. C.C.P. art. 2126(A), the Department of Civil Service informed Mr. Williams of the estimated costs of appeal. This letter also informed Mr. Williams that the costs must be paid by February 15, 2023, calculated in accordance with La C.C.P. art. 2126(B). Mr. Woods has not requested an extension of time or a reduction of the costs for the appeal. Therefore, because Mr. Woods has not paid the costs of appeal, he has abandoned the appeal.

Therefore, the appeal is hereby DISMISSED.
