Detailed position description: Utility Senior Services Administrator manages the Environmental Affairs Department and the 23 employees of the department in the Stormwater and Pretreatment Sections. The duties include wastewater operation and maintenance, pretreatment of industrial waste and Fats Oil and Grease management of Food Service Facilities. Air quality management of the East Bank Sewer Treatment Plant and Carrollton Water Plant which involves compliance with the Title V Air Permit. Stormwater management as it pertains to the Municipal Separate Storm Sewer System Permit. This involves the preparation of the discharge monitoring reports, overseeing enforcement action of illicit discharges and review of inspections of commercial users and construction sites. Review and implementing Risk Management Plan for extremely hazardous substances at the Carrollton Water Plant. Hazardous waste management at SWBNO facilities. Green infrastructure management and Underground Storage Tank, UST, management to comply with State environmental regulations and the Third Modified Consent Decree. Approving public outreach conducted by Environmental Affairs Department which is required by the Third Modified Consent Decree.

3. Description of how similar qualifications are not readily available in the labor market at minimum entrance rate:

Qualifications of experience with wastewater treatment and collection and water treatment, distribution and production needed to manage the Environmental Affairs Department and additional duties of managing the Wastewater Treatment Plant are not readily available for a person with four years experience. A person with five operator's certifications in this field, knowledge and decision making ability gained with the 30+ years' experience are likely not to accept position at the minimum entrance level. One with these qualifications likely will be making considerably more than the minimum.

4. How are the duties of the position relevant to the advanced qualification?

In addition to managing the Environmental Affairs Department, Ann Wilson, has assumed the duties of managing the East and West Bank Wastewater Treatment Plants. Ms. Wilson has taken on additional duties of assuring compliance with the Third Modified Consent Decree, Title V Air Permit compliance and preparing cases for environmental enforcement action.

5. How will hiring this person at the rate specified below be a financial advantage to the City? Please provide an objective financial analysis.

SWBNO would have to hire additional contractors and/or Board personnel to oversee the contract of the WWTP including operation, maintenance, laboratory, environmental compliance, safety, capital projects and compliance regulations. Ann Wilson is managing the Title V Air Permit compliance for both the East Bank Sewer Treatment Plant and the Carrollton Water Plant. This has eliminated and/or reduced the need for outside consultants. Risk Management Plan for the Carrollton Water Plant is now done by Ann Wilson and eliminated the need for outside consultant. Consent Decree review and verify compliance has resulted in maintaining compliance without the use of outside consultants for Green Infrastructure, Fluidized Bed Incinerator, Outreach and LDEQ/EPA Coordination requirements. These job duties performed by Ms. Wilson has led to less frequent stipulated penalties under the Consent Decree and reduced number of enforcement actions from LDEQ and EPA.
