ORDER

The Sewerage & Water Board moved for summary disposition of Mr. Young’s disciplinary appeal on the basis that his appeal was untimely under Civil Service Rule II, section 4.3. The Commission heard oral argument on this motion at its regular meeting on January 19, 2024. The Sewerage & Water Board provided written notice to Mr. Young of his suspension by letter dated September 19, 2023. Mr. Young filed an appeal of this suspension on November 15, 2023. Rule II, section 4.3 provides that “[a]ppeals to the Commission must be actually received in the Department of Civil Service no later than the close of business on the thirtieth (30th) calendar day following the date of the disciplinary letter provided by the Appointing Authority.” Because Mr. Young failed to file his appeal within 30 calendar days of September 19, 2023, his appeal is untimely.

The Sewerage & Water Board’s motion for summary disposition is granted, and Mr. Young’s appeal is dismissed.
