The Parties' motion is hereby GRANTED.



FINAL AGREEMENT


NOW COME the parties, through undersigned counsel, who represent that a final agreement was reached resolving *Ashley Wolfe v. Department of Fire*, C.S. Nos. 9695. Pursuant to C.S. Rule 11, Section 6.7, the parties herein have agreed to resolve these matters prior to and in lieu of proceeding with a Civil Service hearing. Specifically, the Department of Fire has agreed to rescind the eighty-four (84) hour suspension and to remove said suspension from Mr. Wolfe's personnel file. The Department of Fire has further agreed to reimburse Mr. Wolfe for all back pay and other emoluments only for the portion of his eighty-four-hour (84) suspension that he actually served in the form of a deduction from his SDO (Scheduled Days Off) including any earned accruals of annual, sick and leave that would have been distributed during that period. Accordingly, Mr. Wolfe agrees to pay \$248.96, which reflects the ten (10) hour labor cost associated with the repair of District Chief 503 Door at Station 27 and withdraw his appeal of the suspension in C.S. Docket Number 9695.

WHEREFORE the parties, through signature of undersigned counsel, request that this Agreement be entered into the record and acknowledged by the Commission at its next meeting.
