**ORDER**

The Department of Safety & Permits moved for summary disposition on the basis that Ms. Youngblood has no right of appeal as a probationary employee under Civil Service Rule II, § 4.1. The Commission heard oral argument on this motion at its July 12, 2024, regular meeting.

Civil Service Rule II, § 4.1 grants a right of appeal to “[r]egular employees in the classified service.” A “regular employee” is “an employee who has been appointed to a position in the classified service in accordance with the Law and these Rules and who has completed the working test period.” Ms. Youngblood one-year probationary period began on March 17, 2024, and she was terminated on May 18, 2024. Because she did not complete her working test period, she has no right of appeal as a regular employee.

Ms. Youngblood’s appeal is dismissed.
