This matter came before the Commission on October 11, 2024. On March 21, 2024, Mr. Brandon Plains filed a motion to appeal his judgment of February 23, 2024 to the 4<sup>th</sup> Circuit Court of Appeal. The Commission granted the appeal. On April 24, 2024, in accordance with La. C.C.P. art. 2126(A), the Department of Civil Service informed Mr. Plains of the costs to appeal this matter. Mr. Plains did not pay the appeal costs by the deadline.


Therefore, because Mr. Plains has not paid the costs of appeal, which were due on May 14, 2024, his appeal is dismissed.
