DECISION

Appellant, Ronald Cordier, brings this appeal pursuant to Article X, § 8(A) of the Louisiana Constitution and this Commission's Rule II, § 4.1 seeking relief from his three-day suspension beginning June 15, 2020. (Exhibit HE-1). At all relevant times, Appellant had permanent status as an Automotive Maintenance Technician. (Tr. at 46-47; HE-1). A Hearing Examiner, appointed by the Commission, presided over a hearing on August 25, 2020. At this hearing, both parties had an opportunity to call witnesses and present evidence.

The undersigned Commissioners have reviewed and analyzed the entire record in this matter, including the transcript from the hearing, all exhibits submitted at the hearing, the Hearing Examiner's report dated December 28, 2020, and controlling Louisiana law.

For the reasons set forth below, Cordier's appeal is DENIED.

I. ANALYSIS

It is well-settled that, in an appeal before the Commission pursuant to Article X, § 8(A) of the Louisiana Constitution, the appointing authority has the burden of proving by a preponderance of the evidence: 1) the occurrence of the complained of activity, and 2) that the conduct complained of impaired the efficiency of the public service in which the appointing authority is engaged. *Gast v. Dep't of Police*, 2013-0781 (La. App. 4 Cir. 3/13/14), 137 So. 3d 731, 733 (quoting *Cure v.*

Dep't of Police, 2007-0166 (La. App. 4 Cir. 8/1/07), 964 So. 2d 1093, 1094). The Commission has a duty to decide independently from the facts presented in the record whether the appointing authority carried its legally imposed burden of proving by a preponderance of evidence that it had good or lawful cause for suspending and terminating the classified employee and, if so, whether such discipline was commensurate with the dereliction. Abbott v. New Orleans Police Dep't, 2014-0993 (La. App. 4 Cir. 2/11/15); 165 So.3d 191, 197; Walters v. Dept. of Police of the City of New Orleans, 454 So. 2d 106 (La. 1984).

The parties stipulated that the conduct at issue is a violation of CAO policy and would justify a three-day suspension. (Tr. at 6). Therefore, the only issue for these Commissioners is whether the conduct occurred.

The Appointing Authority disciplined Appellant by letter dated June 12, 2020, for urinating in a hand-washing station on June 4, 2020. (Ex. HE-1). The hand-washing sink is on the west side of the shop across from the intake desk, and there is a window above the sink. (Tr. at 9-10). Timothy Comeaux, who was serving as an interim supervisor in June of 2020, testified that while he was standing to the side of the sink with his back to the wall directing a truck backing into the shop, Appellant was standing at the hand-washing station. (Tr. at 7, 13). Another employee was on the outside of the shop, looking through the window to help with guiding the truck. (Tr. at 36). A tool cage is located next to the sink. (Tr. at 10-11). Comeaux was next to Appellant, although Comeaux was 6-7 feet away from Appellant. (Tr. at 11, 18).

Comeaux testified he saw urine going into the sink and witnessed Appellant "putting himself up." (Tr. at 8). On cross-examination, Comeaux testified he saw Appellant pull his zipper "and that stuff." (Tr. at 23). Comeaux said "that is nasty" out loud, and, according to Comeaux,

the employee driving the vehicle into the shop said, "man, it always smells like urine in there."

(Tr. at 9).

Darius Taylor, a Mechanic III who was driving the vehicle, testified he witnessed Appellant

standing at the sink, but he could not see what Appellant was doing at the sink. (Tr. at 29-30).

Taylor testified that Comeaux was "ground guiding" Taylor into the shop. (Tr. at 30). Taylor

testified that it always smells like urine around the sink and that two weeks prior, he had seen

Appellant walking away from the sink zipping up his pants. (Tr. at 33-34). Taylor has never seen

anyone else urinate in the sink. (Tr. at 33-34).

Appellant testified that he was washing his hands and that he did not urinate in the sink.

(Tr. at 48). Brian Gangole testified that a fan would have obstructed Comeaux's view. (Tr. at 44).

Appellant agreed that the sink smells like urine. (Tr. at 50).

Based on the testimony of the Timothy Comeaux and Darious Taylor, which the

Commissioners find to be credible, the undersigned Commissioners find that the Appointing

Authority has carried its burden of showing the complained-of activity.

The appeal is DENIED.
