ORDER

The Commission granted Ms. Braxton-Robertson's appeal of her termination of employment on April 9, 2024. Ms. Braxton-Robertson requested to address the Commission about her reinstatement. At the Commission's July 12, 2024, regular meeting, Ms. Braxton-Robertson and counsel for the Sewerage & Water Board appeared.

Ms. Braxton-Robertson informed the Commission that the Sewerage & Water Board has reinstated her to a less desirable position (meter reader) than the position she held before her termination, Water Service Inspector II. The current title is Water Meter Reader and Services Technician (C3142). Ms. Braxton-Robertson also complained that the Sewerage & Water Board had failed to supply her with a key fob to drive a Sewerage & Water Board vehicle.

The Commission granted the Sewerage & Water Board 15 days to supply the Commission with briefing about the issues raised by Ms. Braxton-Robertson, including the Sewerage & Water Board's assertion that it removed Ms. Braxton-Robertson's driving privileges before her termination of employment. The Sewerage & Water Board shall file any legal memoranda on or before July 29, 2024.
