ORDER

Appellant Sadra Hamilton moved for summary disposition pursuant to Civil Service Rule II, § 6.1(f), on the basis that the March 8, 2024, letter of termination issued by the Sewerage & Water Board failed adequately to inform Ms. Hamilton of the details of the allegation that she provided “manufactured documents” to the Sewerage & Water Board. The Commission heard oral argument on this motion at its regular meeting on May 30, 2024. Both parties were represented by counsel.

The Sewerage & Water Board informed the Commission that the allegation about manufactured documents did not form the basis for the termination of Ms. Hamilton in its written opposition to the motion and during oral argument. Because the Sewerage & Water Board will not rely on this allegation at the hearing of this matter, Ms. Hamilton’s motion for summary disposition is denied. The reference to falsification of records shall be stricken from the letter of termination, and all evidence of falsified documents shall be excluded from evidence at the hearing of this matter.
