Daniel McElmurray is a seasoned mid-career professional with 24 years of experience in the field. He is highly regarded by the professional community and brings to the table extensive experience in areas of fundamental importance to the mission of Parks and Parkways. He has been employed as the Director of Planning for the Southeast Georgia Regional Development Center and the City of Hartsville and Interim Director at Tulane University. Other experience includes Director of Landscape Architecture for the WLB Group and Project Manager for the City of New Orleans Capital Projects Administration (CPA). He holds a Master of Landscape Architecture degree from LSU and a Master of Urban Planning degree from Clemson University.

Mr. McElmurray is proficient in AutoCAD, Photoshop, Adobe Acrobat 9 and MS Office and has interfaced with many of the same agencies and departments that he will be required to interface with on behalf of Parkways for the completion of projects.

## Wage comparison and Cost savings - Landscape Architect

The landscape architect at Parkways will be performing both design/project management work as well as plan review work. A landscape architect consultant typically charges between 10% to 15% of an overall project budget for design and project management fees. This means that in order to be cost effective, the landscape architect would need to work on a minimum of \$400,000 - \$600,000 worth of projects per year. Between the cost of the projects that the landscape architect will perform plan reviews on behalf of the Department and the cost of the projects that the landscape architect will manage on behalf of the Parkways Department, it is very safe to say that the landscape architect will be involved in far more than \$3 million worth of projects per year.

Capital Projects Administration has compiled a spreadsheet to determine the average hourly rate for a landscape architect consultant. The average landscape architect consultant charges an hourly rate of average of \$150 per hour. That figure far exceeds the hourly wage we are offering Mr. McElmurry.
