Very responsible supervisory and professional work in the performance of advanced and complex chemical, microbiological, and physical tests; and related work as required. Ensures that approved procedures are followed, and that the microbiological lab section complies with LDH and EPA certification requirements. Maintains equipment and orders supplies. Prepare reports of analytical results for SWB, LDH, and EPA. Supervise and train subordinate microbiologists, laboratory technicians, and sample collectors. Assist laboratory supervisor with administrative matters. Conduct investigations of customer complaints regarding water quality. Advise Laboratory and Water Purification Department supervisors regarding water treatment and water quality issues.

- 3. Description of how similar qualifications are not readily available in the labor market at minimum entrance rate: There are 2 applicants on the eligible list, and the other applicant did not respond to multiple attempts to schedule an interview.
- 4. How are the duties of the position relevant to the advanced qualification? Ms. Muheisen's graduate education and work experience in clinical laboratory settings greatly exceeds the minimum requirements of this position and will be a valuable asset in improving SWB Laboratory.
- 5. How will hiring this person at the rate specified below be a financial advantage to the City? Please provide an objective financial analysis. One of our two microbiologists recently retired. Ms. Muhelsen is the only candidate we have found this year interested in the position; however, she will not accept the minimum hiring rate. Hiring her at the requested rate will fill a vacancy, and ensure continuity of laboratory operations in the absence of the other microbiologist. Failure to fill this position may result in the need to outsource microbiological testing, increasing costs and delaying sample results reporting. Ms. Muheisen will need minimal training to learn the SWB Lab's workflow. In addition, the SWB Laboratory Chemistry sections are in the process of purchasing new instruments and developing procedures to perform analyses in-house that are currently performed by contract laboratories and converting some workflow from manual analyses to automated analyses. Because of her extensive experience with a variety of advanced and complex laboratory instrumentation and analyses, Ms. Muheisen will also be assigned to assist with this transition. She will assist with training less experienced chemists, developing procedures, and assuring that proper quality control methods are in place. Hiring Ms. Muheisen will help to reduce financial costs and time associated with sending samples to contract labs; it will reduce laboratory expenses related to hiring outside trainers; and, in addition to filling a vacancy in the Microbiology section, will eliminate the need to hire another experienced chemist in the Chemistry sections.
