


AGREEMENT

NOW COME the parties herein, through undersigned counsel, who represent that an agreement has been reached resolving the above captioned Civil Service ("CS") appeal, prior to and in lieu of proceeding with the CS hearing scheduled on November 30, 2021. The New Orleans Police Department ("NOPD") has agreed to reduce the one-day suspension issued for violation of Rule 4, Paragraph 4, C-6, NOPD Chapter 1.3.6 Use of Force Reporting subsection 27 under PIB #2019-0494-R to a written letter of reprimand and one (1) day of training with Force Investigation Team ("FIT"), and Sgt. Davis shall be reimbursed for the one-day suspension served.

In response to NOPD's agreement to reduce the one-day suspension issued for violation of Rule 4, Paragraph 4, C-6, NOPD Chapter 1.3.6 Use of Force Reporting subsection 27 under PIB #2019-0494-R to a written letter of reprimand and one (1) day of training with FIT and to reimburse the one-day suspension served, Appellant has agreed to withdraw his appeal in this matter.

WHEREFORE, the parties herein, through undersigned counsel, agree to the terms stated herein as confirmed by the signature of their counsel. The parties further request that this Agreement be presented to the Commission at its next scheduled meeting.
