AGREEMENT

NOW COME the parties, through undersigned counsel, who represent that an agreement was reached resolving Francis Williams II v. Department of Fire, CS Appeal 9632. Pursuant to CS Rule II. Section 6.7, the parties herein have agreed to resolve this matter prior to and in lieu of proceeding with a Civil Service Hearing. Specifically, the Department of Fire agrees that if at any time within five years from the date of this agreement, Chief Francis Williams provides to the Department of Fire, an authorization from all treating physicians which complies with La R.S. 33:2550, and which certifies that Francis Williams is able to perform the essential functions of the position of Fire District Chief that were required at the time he was originally confirmed in such position, he will be eligible for reemployment. Department of Fire reserves its right pursuant to La R.S. 33:2550 to dispute the certification of employee's treating physicians and have Francis Willaims II evaluated by another physician. Such eligibility includes reemployment with the departmental and promotional seniority Francis Williams II had accrued as of the date of his retirement, but includes a break in service only for such time as Chief Francis Williams II remains retired. Chief Francis Williams II is to be reemployed at the position of Fire District Chief, subject to availability. If no current position is available equivalent to Fire District Chief, Francis Williams If will be rehired and placed in a position of any lower class and shall be placed first on the eligibility list for a position in his former class as required by La R.S. 33:2550. Francis Williams II will not be required to retest with Civil Service as La R.S. 33:2550 will control. Chief Francis Williams II agrees to withdraw his Civil Service Appeal docketed as CS No. 9632 and does not appeal his forced retirement.

WHEREFORE, the parties, through undersigned counsel, request this Agreement be entered into the record, and acknowledged by the Commission at its next meeting.
