ORDER

The Recreation Department (NORD) moved for summary disposition of Davis's appeal for failure to prosecute under Civil Service Rule II, § 6.3. The Commission heard oral argument on this motion at its April 10, 2026, regular meeting, after continuing the hearing from March 13, 2026, at Davis's request.

Davis failed to appear for his scheduled hearing on February 26, 2026, at 9:00. In advance of the hearing, the Hearing Examiner offered to move the time of the hearing to 11:00, so Davis could attend a medical appointment. Davis informed the Hearing Examiner he would attend at 9:00 on February 26. NORD offered time records showing that Davis was working at the time set for hearing on February 26.

NORD's motion for summary disposition is GRANTED based on Davis's failure to prosecute his appeal.
