**ORDER**

The Sewerage & Water Board moved for summary disposition of Mr. Trask's disciplinary appeal on the basis that his appeal is untimely. The Commission heard oral argument on this motion at its regular meeting on May 30, 2024.

The Sewerage & Water Board terminated Mr. Trask's employment by letter dated February 15, 2024, and he appealed this discipline on March 26, 2024. Civil Service Rule II, § 4.1 requires employees to file appeals of discipline within 30 calendar days of the date of the disciplinary action. Mr. Trask's appeal is untimely.

The Commission grants the Sewerage & Water Board's motion for summary disposition on the basis that Mr. Trask's appeal is untimely.
