## **MINUTE ENTRY**

This matter came before the Commission on July 12, 2024. On February 7, 2024, Mr. Stephen M. Smith, Appellant's counsel, filed a motion to appeal his judgment of January 8, 2024 to the 4<sup>th</sup> Circuit Court of Appeal. The Commission granted the appeal. On February 26, 2024, in accordance with La. C.C.P. art. 2126(A), the Department of Civil Service informed Mr. Crusto's counsel of the costs to appeal this matter. Mr. Crusto's counsel requested an extension of time in which to pay the fees. The extended date to pay 4<sup>th</sup> Circuit fees was April 8, 2024.

Therefore, because Mr. Crusto has not paid the costs of appeal, which were due on Apil 8, 2024, his appeal is dismissed.
