ORDER

The Department of Sanitation moved for summary disposition on the basis that it had imposed no discipline on Mr. Holly, so he has no right of appeal. The Commission heard oral argument on this motion at its July 12, 2024, regular meeting.

Mr. Holly complained that the Department of Civil Service refuses to certify Mr. Holly as eligible for the position of Fire Recruit because of his record of a positive drug test while employed in the Department of Sanitation in 2022. The Commission informed Mr. Holly that he may have the positive result removed by completing an approved rehabilitation program under Civil Service Rule V, § 9.16.

Because the Department of Sanitation imposed no discipline on Mr. Holly, he may not bring an appeal against the Department of Sanitation based on the treatment of the drug test.

Mr. Holly's appeal is dismissed.
