MINUTE ENTRY

This matter came before the Commission on Friday, December 13, 2024 through the Appointing Authority’s Motion to Dismiss Appellant’s Appeal for Lack of Prosecution pursuant to Rule II, 4.13 (b). Our Rules provide for dismissal of an appeal when an appellant fails to appear for a scheduled hearing. The Appellant failed to appear at the time and location established for Appellant’s appeal hearing.

On Tuesday, July 23, 2024, a hearing examiner appointed by the Commission presided over an appeal hearing related to the underlying appeal. Present at the hearing was counsel for the Appointing Authority and its witnesses, Chief Executive Officer, Larry Barabino, Jr. and Athletic Director, Jermaine Hall. The Appellant nor counsel for the appellant appeared. Counsel for the Appointing Authority made a motion to dismiss the appeal, pursuant to Civil Service Rule II, Section 4.13(b), which was accepted by the Hearing Examiner.

As a result of the foregoing, the Commission GRANTED the Motion to Dismiss Appellant’s Appeal.


