AGREEMENT

NOW COME the parties herein, through undersigned counsel, who represent that an agreement has been reached resolving the above captioned matter. Counsel for the parties appeared before a hearing examiner on January 13, 2022 and entered the terms of this agreement into the record. The terms of the parties' agreement are restated herein for presentation to and acknowledgment by the Civil Service Commission.

The appointing authority, New Orleans Police Department ("NOPD"), agreed to withdraw one of the three disciplinary actions taken under PIB # 2019-0449-R: Violation 3, relative to the discipline of one-day suspension for violation of NOPD's Rule 4, Performance of Duty; Paragraph 4, Neglect of Duty, subparagraph C-6, failing to comply with instructions, oral or written, from any authoritative source relative to Homicide Duties and Responsibilities. Accordingly, the total suspension issued in connection with PIB #2018-0693-R will be reduced from three (3) working days to two (2) working days. NOPD agrees that the appellant's disciplinary record will be corrected to reflect withdrawal of this sustained violation.

In consideration of the foregoing agreement by NOPD, the appellant, Sarah Cherny, agreed to withdraw her appeal.


