

ORDER

In an amended decision issued November 15, 2023, the Commission ordered the Department of Recreation to reinstate Mr. Hall and to reimburse him for lost wages from April 20, 2023, to the date of the order. The Commission has granted Mr. Hall's motion to appeal this decision. Because this appeal is devolutive, the parties must comply with the Commission's judgment.

Mr. Hall requested to address the Commission on the basis that the calculation of his backpay by the Department of Recreation is incorrect. The Commission heard Mr. Hall's argument at its January 19, 2024, regular meeting. Counsel for the Department of Recreation agreed to provide the record of the calculation of backpay by the Department of Recreation to the Commission and Mr. Hall by January 29, 2024. Mr. Hall can then provide to the Commission the basis for his statements that the calculation of backpay is in error. The Commission defers consideration of this matter to its February 9, 2024, regular meeting, following the receipt of the additional documents and information.
