ORDER

The Department of Health moved for summary disposition of Ms. Thomas's disciplinary appeal on the basis that she has no right of appeal as a probationary employee. The Commission heard oral argument on this motion at its regular meeting on May 30, 2024. Ms. Thomas appeared *pro se*.

Ms. Thomas's one-year probationary period began on January 3, 2024, and she was terminated on April 4, 2024. Civil Service Rule II, § 4.1 grants a right of appeal to "[r]egular employees in the classified service." A "regular employee" is "an employee who has been appointed to a position in the classified service in accordance with the Law and these Rules and who has completed the working test period." Civil Service Rule I(64). Ms. Thomas was a probationary employee, so she has no right of appeal under Rule II, § 4.1.

The Commission grants the Department of Health's motion for summary disposition.
