FRENCH MARKET CORPORATION Appointing Authority

DECISION

Appellant, Anthony Woods, brings this appeal pursuant to Article X, § 8(A) of the Louisiana Constitution and this Commission's Rule II, § 4.1 seeking relief from his 30-day suspension beginning August 29, 2019, and his termination effective September 28, 2019. (See Exhibit HE-1, HE-2). The French Market Corporation provided Woods with written notice of his emergency suspension and pre-termination hearing by letter dated September 5, 2019. (Ex. HE-1). The French Market Corporation scheduled Woods' pre-termination hearing for September 11, 2019. (Ex. HE-1). Following the date of the scheduled pre-termination hearing, which Woods failed to attend, The French Market Corporation provided Woods with written notice of his September 28, 2019, termination by letter dated September 20, 2019. (Ex. HE-2). At all relevant times, Appellant was employed as a Painter at the French Market Corporation and had permanent status as a classified employee. A Hearing Examiner, appointed by the Commission, presided over a hearing. At this hearing, both parties had an opportunity to call witnesses and present evidence.

The undersigned Commissioners have reviewed and analyzed the entire record in this matter, including the transcript from the hearing, all exhibits submitted at the hearing, the Hearing Examiner's report, and controlling Louisiana law. For the reasons set forth below, we DENY the appeal.

I. ANALYSIS

It is well-settled that, in an appeal before the Commission pursuant to Article X, § 8(A) of the Louisiana Constitution, the appointing authority has the burden of proving by a preponderance of the evidence: 1) the occurrence of the complained of activity, and 2) that the conduct complained of impaired the efficiency of the public service in which the appointing authority is engaged. *Gast v. Dep't of Police*, 2013-0781 (La. App. 4 Cir. 3/13/14), 137 So. 3d 731, 733 (quoting *Cure v. Dep't of Police*, 2007-0166 (La. App. 4 Cir. 8/1/07), 964 So. 2d 1093, 1094). The Commission has a duty to decide independently from the facts presented in the record whether the appointing authority carried its legally imposed burden of proving by a preponderance of evidence that it had good or lawful cause for suspending the classified employee and, if so, whether such discipline was commensurate with the dereliction. *Abbott v. New Orleans Police Dep't*, 2014-0993 (La. App. 4 Cir. 2/11/15); 165 So.3d 191, 197; *Walters v. Dept. of Police of the City of New Orleans*, 454 So. 2d 106 (La. 1984).

The French Market Corporation suspended and then terminated Woods following an August 23, 2019, incident between Woods and his supervisor, Robert Matthews. (Ex. HE, HE-2; Tr. at 11). Woods visited the worksite on August 23 to provide Matthews with documentation of an absence the previous week caused by a court appearance. (Tr. at 34-35, 97). Matthews was seated behind a desk at Building C of the French Market. (Tr. at 33). According to Matthews, Matthews was on the phone, and Wood said "here is the Fing ticket." (Tr. at 35). Woods became angry when Matthews asked Woods to photocopy the document "on his day off." (Tr. at 99). Woods said to Matthews, "If I don't get paid, something is going to happen." (Tr. at 36). Woods threw Matthews against the wall, grabbing Matthews with one hand by Matthews' neck. (Tr. at 39). Yolanda Diaz, who is employed by the janitorial company and witnessed this incident,

testified at the hearing, corroborating these incidents, including the use of profanity and the

physical altercation. (Tr. at 55, 68-69).

Rhonda Sidney, the Human Resources Director for the French Market Corporation,

testified that Matthews was shaken and upset when he reported this incident to her on August 23.

(Tr. at 12). Ms. Sidney interviewed Yolanda Diaz the same day. (Tr. at 14). Ms. Sidney also

reported the incident to the New Orleans Police Department, (Tr. at 15), who came to the French

Market and interviewed Matthews. (Tr. at 42, 44). Matthews elected not to press criminal charges

against Woods. (Tr. at 44).

Kathleen Turner, the Executive Director, testified that this incident, which she described

as a physical assault with a witness, results in an atmosphere of intimidation, impairing the

efficiency of the French Market Corporation. (Tr. at 77, 84).

The Appointing Authority has carried its burden of proof that the complained-of conduct

occurred and that it impaired the efficiency of the public service. Because of the incident involved

a physical assault on a supervisor, the penalties of a suspension and termination are commensurate

with the infraction.

Appellant's appeal is denied.
