MINUTE ENTRY


This matter came before the Commission on Friday, December 13, 2024 through the Appointing Authority's Motion to Dismiss Appellant's Appeal for Lack of Prosecution pursuant to Rule II, 4.13 (b). Our Rules provide for dismissal of an appeal when an appellant fails to appear for a scheduled hearing. The Appellant failed to appear at the time and location established for Appellant's appeal hearing.

On October 22, 2024, a hearing examiner appointed by the Commission presided over an appeal hearing related to the underlying appeal. Counsel for the Appointing Authority and its witnesses, Finance Director, Romy Samuel; Revenue Collector Assistant, Wendell McCall; Finance staffer, Patrice Lee-Fleming; and Human Resources staffer, Corneisha Brown, were present at the hearing. Appellant nor legal counsel for the Appellant appeared. Counsel for the Appointing Authority made a motion to dismiss both appeal numbers 9648 and 9649, pursuant to Civil Service Rule II, Section 4.13(b), which was accepted by the Hearing Examiner.

As a result of the foregoing, the Commission GRANTED the Motion to Dismiss Appellant's Appeals.
