Suzanne Herzog is a seasoned mid-career professional with 15 years of experience in the field. She is highly regarded by the professional community and brings to the table extensive experience in areas of fundamental importance to the mission of Parks and Parkways. She has been employed with two prominent New Orleans architecture firms in addition to internships.

Mrs. Herzog is proficient in AutoCAD, Photoshop, Adobe Acrobat 9, MS Office and SketchUp.

Mrs. Herzog has extensive experience and knowledge of green infrastructure technology through a number of built projects which she designed and managed during her ten years as a Landscape Architect with Mathes Brierre Architects and her prior position as Project Manager with Perez Architects. Her skillset is very important in light of the new Comprehensive Zoning Ordinance, recently adopted by the City, which mandates green infrastructure techniques for water management. Because green infrastructure is an emerging field, practitioners with experience in the field are not readily available although the demand for professionals with this specialized knowledge is very high. Parks and Parkways is responsible for over 2,000 acres of public land. As such, Parkways is a major stakeholder in the field of green infrastructure and must retain professionals with relevant expertise in order to comply with environmental ordinances and satisfy public demand. Mrs. Herzog also brings to the table experience with playground and athletic field design, which are also particularly relevant to the mission Parkways.
