

**AGREEMENT**

**NOW COME** the parties, through undersigned counsel, who represent that an agreement was reached resolving Raven Jackson v. Department of Public Works, 9579. Pursuant to CS Rule II, Section 6.7, the parties herein have agreed to resolve this matter prior to and in lieu of proceeding with a Civil Service Hearing. Specifically, the Department of Public Works will rescind the termination issued to Raven Jackson and reinstate her to the job position held at the time of termination with back pay from the date of termination, March 6, 2024. Ms. Jackson agrees to resign from her employment effective June 26, 2024, and withdraw her Civil Service appeal docketed as CS No. 9579.
