ORDER

Appellant, Catina Braxton-Robertson, has moved the Commission to waive the appeal costs payable to the Department of Civil Service under Civil Service Rule II, Section 9.2. This motion is in relation to her motion to appeal the Commission's July 28, 2025, denial of her appeal of the termination of her employment to the Fourth Circuit Court of Appeal. The Commission heard oral argument on this motion at its November 14, 2025, regular meeting.

Ms. Braxton-Robertson bases this motion to waive costs on a lack of means. Ms. Braxton-Robertson has provided an affidavit in support of this motion, and she has attested that her income is less than 125% of the federal poverty level following the termination of her employment. Ms. Braxton-Robertson confirmed that the contents of the affidavit are correct during oral argument. Ms. Braxton-Robertson has met the requirements for the Commission to waive the appeal costs payable to the Department of Civil Service under Civil Service Rule II, Section 9.2.

The Commission GRANTS Ms. Braxton-Robertson's motion to waive appeal costs payable to the Civil Service Department.
