Description of how similar qualifications are not readily available in the labor market at minimum entrance rate: The years of experience as an RN and as a supervisor at a quality facility are difficult to recruit for as most people would not leave this positions easily. We have been unable to attract RN's without Advanced Practice Degrees to work in our inner city facility. Advanced practice nurses also command much higher rates of pay and are beyond the qualifications we are seeking for this position. Several persons inquired, but did not meet residency requirements and unwilling to move into the city, so they did not complete the formal process with civil service.

- 4. How are the duties of the position relevant to the advanced qualification?

  RN experience is key to working with the high risk population we serve. An RN with increased experience would be the preference. Ms. Davis's 5 years of supervision experience is extremely important as we continue to experience turnover in the clinic and a consistent leader with several years' experience would be a positive to help provide consistent direction and leadership.
- 5. How will hiring this person at the rate specified below be a financial advantage to the City? Please provide an objective financial analysis. The hiring of an experienced RN who has worked with the clientele we service (by virtue of the location of her current place of employment and interview) will help us to retain her as the supervisor for the program. For the cost of70,643 + benefits we will be able to provide supervision to the clinic that provides over 6,000 patient visits to the community, and supervision of 7 FTE's for the program including professional staff.
