



AGREEMENT

NOW COME the parties, through undersigned counsel, who represent that an agreement was reached resolving Robbie Milliet v. Department of Fire, CS Appeal 9619. Pursuant to CS Rule II, Section 6.7, the parties herein have agreed to resolve this matter prior to and in lieu of proceeding with a Civil Service Hearing. Specifically, the Department of Fire will reclassify the vehicle accident of April 5, 2024 involving NOFD vehicle FD#1187 from a Class B Preventable accident to a Class C Line of Duty Preventable Accident. Operator Milliet agrees to withdraw his Civil Service Appeal docketed as CS No. 9619 and does not appeal the discipline of remedial training Module 1: Common Accidents at MTA and a Letter of Reprimand.

WHEREFORE, the parties, through undersigned counsel, request that this Agreement be entered into the record, and acknowledged by the Commission at its next meeting.
