ORDER

The Sewerage & Water Board moved for summary disposition of Mr. Robinson's appeal pursuant to Civil Service Rule II, Section 4.1, on the basis that Mr. Robinson has no right of appeal as a probationary employee. Mr. Robinson filed a motion to amend his appeal to allege sex discrimination. The Commission heard argument on Mr. Robinson's motion to amend and the Sewerage & Water Board's motion for summary disposition at its October 29, 2025, regular meeting.

The Commission grants Mr. Robinson's motion to amend, as this motion was filed within the 30-day deadline for appeals of discipline. The Commission defers the Sewerage & Water Board's motion for summary disposition without date.
