**ZONING DOCKET 078/13** – Request by C & S DENTAL HEALTHCARE LLC for a Conditional Use to permit an accessory parking lot for a main use within 300' of said lot in an LRS-1 Lakeview Single-Family Residential District, on Square 272, lot 41 and 42, in the Second Municipal District, bounded by French and Louis 14<sup>th</sup> Streets, Harrison Avenue and Canal Boulevard. The municipal address is 6258 CANAL BOULEVARD. (PD-5)

**ZONING DOCKET 079/13** – Request by ISIDORE NEWMAN SCHOOL for a Conditional Use to permit a school in an RD-2 Two Family Residential District and a B-1 Neighborhood Business District, on Square 493-A, All Lots or Lots A, B, Pt. C, Pt. C.D, E, F, G, H, S, Y and Z; Square 531-A, portions of Lot N-S; and a portion of the former Saratoga and Dufossat Streets rights of way, in the Sixth Municipal District, Bounded by Danneel, Loyola and Soniat Streets and Jefferson Avenue.
