THE CITY PLANNING COMMISSION, IN ACCORDANCE WITH PROVISIONS OF ARTICLE 16 OF THE COMPREHENSIVE ZONING ORDINANCE NUMBER 4264 M.C.S., AS AMENDED, AND IN ACCORDANCE WITH PROVISIONS OF THE REVISED STATUTES OF THE STATE OF LOUISIANA AND THE CITY CHARTER REGARDING PROPERTY DISPOSITIONS AND SUBDIVISIONS, WILL HOLD PUBLIC HEARINGS ON TUESDAY, JULY 23, 2013 ON THE FOLLOWING PROPOSED AMENDMENTS TO THE COMPREHENSIVE ZONING LAW, PROPERTY DISPOSITIONS AND SUBDIVISIONS. THE COMMISSION WILL TAKE ACTION OR MAKE A RECOMMENDATION AT THE CONCLUSION OF EACH PUBLIC HEARING.

A. UNFINISHED BUSINESS:

- ZONING DOCKET 061/13 Request by CITY COUNCIL MOTION M-13-137 to consider amendments to Article 10 "Overlay Zoning Districts, Miscellaneous Zoning Districts, Planned Development Districts and Design Review Districts" of the Comprehensive Zoning Ordinance No. 4264 M.C.S., as amended, to amend existing design standards in Section 10.1 UC Urban Corridor District, 10.2 Eastern New Orleans Renaissance Corridor District and 10.3 Highway Urban Corridor District relative to Eastern New Orleans. (LM/KC/GM) (DEFERRED FROM THE JUNE 25, 2013 MEETING)
- 2. ZONING DOCKET 062/13 Request by CITY COUNCIL MOTION M-13-140 to consider an amendment to Article 18 of the Comprehensive Zoning Ordinance No. 4264 M.C.S, as amended, and the designation of such on the corresponding zoning base maps of the City of New Orleans, to consider the establishment of the Eastern New Orleans Renaissance Corridor Interim Zoning District, which shall augment the existing standards in the ENORC Eastern New Orleans Renaissance Corridor District, HUC Highway Urban Corridor District and UC Urban Corridor District, to prohibit the issuance of any permits within the above referenced corridor districts that are inconsistent with guidelines established in CITY COUNCIL MOTION M-13-137.
