#### **B.** NEW BUSINESS:

- 1. ZONING DOCKET 064/13 Request by SEVENTH MAGAZINE LLC to amend Conditional Use Ordinance No. 11,244 M.C.S. (ZD032-86) which permitted a retail use in excess of 5,000 square feet, to permit the further expansion of the existing retail development over 5,000 square feet, in a B-1A Neighborhood Business District, on Square 153, Lot 8A, in the Fourth Municipal District, bounded by Camp, Sixth, Seventh and Magazine Streets.
