ZONING DOCKET 064/13 - Request by SEVENTH MAGAZINE LLC to amend Conditional Use Ordinance No. 11,244 M.C.S. (ZD032-86) which permited a retail use in excess of 5,000 square feet, to permit the further expansion of the existing retail development over 5,000 square feet, in a B-1A Neighborhood Business District, on Square 153, Lot 8A, in the Fourth Municipal District, bounded by Camp, Sixth, Seventh and Magazine Streets. The municipal addresses are 2929-37 MAGAZINE STREET. (PD-2)

ZONING DOCKET 065/13 - Request by CEG, INC for a Zoning Change from an RM-2A Multi-Family Residential District to a B-1A Neighborhood Business District, on Square 101, Lots 1, 2 and 3 or undesignated lot, in the Fourth Municipal District, bounded by Laurel, Josephine and Annunciation Streets and Jackson Avenue.
