**ZONING DOCKET 057/13** – Request by CLAIBORNE AVENUE VENTURES LLC for a Conditional Use to permit the sale of alcoholic beverages for on-premise consumption at a standard restaurant in a B-2 Neighborhood Business District and the Inner-City Urban Corridor Overlay District, on Square 695, Lot 2, in the Sixth Municipal District, bounded by Milan, South Derbigny, General Pershing Streets and South Claiborne Avenue. The municipal address is 4235-37 SOUTH CLAIBORNE AVENUE. (PD-2)

**ZONING DOCKET 058/13** – Request by TOTAL FOOT CARE INC for a Conditional Use to permit a non-accessory parking lot in an RO-1 General Office District and the Inner-City Urban Corridor Overlay District, on Square 450, Lots 20 and 21, in the Second Municipal District, bounded by North Jefferson Davis Parkway, Conti and North Rendon Streets and Bienville Avenue. New Orleans Renaissance Corridor District and 10.3 Highway Urban Corridor District relative to Eastern New Orleans.
