ZONING DOCKET 092/13 – Request by CRESCENT ANN REALTY LLC for a Conditional Use to permit four residential units in an HMR-3 Historic Marigy/Treme Residential District, on Square 367, Lots 15 and 16, in the Third Municipal District, bounded by Franklin and Saint Claude Avenues and North Rampart and Port Streets. The municipal address is 1030 PORT STREET. (PD-7)

ZONING DOCKET 093/13 – Request by ARCHLAND PROPERTY I LLC and US REALTY ADVISORS LLC to amend Conditional Use Ordinance No. 21,997 M.C.S. (ZD023-05) which permitted a fast food restaurant with a drive-thru facility, to permit the expansion of the existing drive-thru facility, in a B-2 Neighborhood Business District, within a UC Urban Corridor Overlay District, on Square A-3, Pt. Lot A-3 or Lot A-31-B or Lot A-31B-1, in the Fifth Municipal District, bounded by, General DeGaulle, Westpark, Life Center and Cypress Acres Drives.
