


BOOKER T. WASHINGTON SCHOOL SUMMARY

The proposed new Booker T. Washington School is located on S. Roman Street and is bounded by Erato Street, S. Prieur Street and Earhart Blvd. The School is a replacement of the existing Booker T. Washington School. A large portion of the existing school building has been demolished including the three level classroom building, gymnasium and auxiliary buildings. The portion of the building that remains and will be renovated is approximately 49,618 square feet and includes the auditorium and main entrance portal located on the S. Roman Street side.


The proposed new construction is approximately 154,092 square feet, three levels and includes 50 classrooms, gymnasium, cafeteria, music room, media center and other supporting facilities.

The project site is 4.24 acres and the proposed new building will occupied the larger portion of the site and will include two courtyards approximately 100 feet x 100 feet each. The site includes a bus drop-off area located on the Prieur Street side with queuing for four buses. It also includes parking for 13 vehicles on the S. Roman Street side and 26 vehicles on the S. Prieur Street side.






- ←□ EXTERIOR POLE MOUNTED LIGHT FIXTURE
- EXTERIOR LIGHT FIXTURE, POST TOP MOUNTED














