The total request of \$240,00 was prepared in consultation with CPA, and is as follows: Replacing 278 seats - \$100,000; Repair and painting of walls and ceiling - \$50,000; Remove and replace sound attenuating curtains - \$50,000; Remove and replace all carpet in Council Chamber and antechambers - \$20,000. Purchase and installation of 2 digital video projectors - \$20,000.
