# CITY PLANNING COMMISSION MEETING AGENDA

## **PUBLIC HEARING:**

THE CITY PLANNING COMMISSION, IN ACCORDANCE WITH PROVISIONS OF ARTICLE 16 OF THE COMPREHENSIVE ZONING ORDINANCE NUMBER 4264 M.C.S., AS AMENDED, AND IN ACCORDANCE WITH PROVISIONS OF THE REVISED STATUTES OF THE STATE OF LOUISIANA AND THE CITY CHARTER REGARDING PROPERTY DISPOSITIONS AND SUBDIVISIONS, WILL HOLD PUBLIC HEARINGS ON TUESDAY, JUNE 23, 2015 ON THE FOLLOWING PROPOSED AMENDMENTS TO THE COMPREHENSIVE ZONING LAW, PROPERTY DISPOSITIONS AND SUBDIVISIONS. THE COMMISSION WILL TAKE ACTION OR MAKE A RECOMMENDATION AT THE CONCLUSION OF EACH PUBLIC HEARING.

#### A. UNFINISHED BUSINESS:

- 1. ZONING DOCKET 039/15 Request by BCNO 4, LLC for a Conditional Use to permit an amusement place/theater over 10,000 square feet in floor area and to allow the sale of alcoholic beverages for on-premises consumption at the amusement place/theater in an HMC-2 Historic Marigny/Tremé Commercial District, on Square 153, Lots 7, 2, and 1-5 or 7 & 2 & 1/4 or 15-18, in the Third Municipal District, bounded by Elysian Fields Avenue, Chartres, Royal and Frenchmen Streets. The municipal address is 2121 CHARTRES STREET. (PD 7) (NK)
- 2. SUBDIVISION DOCKET 052/15 Request by CINDY M. MANDINA, CLAUS L. GRASSEL AND ROBERT E. EISTERHOLD to resubdivide Lots 89, 91, 3, 2 and Pt. 1 into Lots 89A and 91A, on Square Park Place and Square B, in the Second Municipal District, bounded by East Park Place, Coscino Place, General Haig Street and Florida Avenue. ZONING DOCKET 051/15 Request by MLW FAMILY INVESTMENTS, LLC for a Conditional Use to permit the sale of alcoholic beverages for off-premises consumption and on-premises consumption at a retail store in a C-1 General Commercial District and an ICUC Inner-City Urban Corridor District overlay, on Square 749, Lot 1, 2, 3, and 4, in the First Municipal District, bounded by Tulane Avenue, and South Pierce, South Scott, and Ulloa Streets. - Amend the "Table Specifying Relationship Between Future Land Use Designations and Zoning Classifications" (also known as the "consistency table") to include MU-1 Mixed-Use Medium Intensity District as consistent with the Residential Post-War Multi-Family Future Land Use Designation. (NK)
