SUDIVISION DOCKET 106/16 - Request by 515 TOULOUSE, LLC to resubdivide Lots 6, 7, 10, 11, 12, 16, A, and B into Lot 6-A, Square 26, in the Second Municipal District, bounded by Toulouse, Chartres, Wilkinson, and Decatur Streets.
