- 2) <u>Consideration:</u> [ZD072/18] Request by Pretty Blue House, LLC for a conditional use to permit a bar in an HMC-2 Historic Marigny/Tremé/Bywater Commercial District, an AC-1 Arts and Culture Diversity Overlay District, and an EC Enhancement Corridor Design Overlay District, on Square 503, Lot A, in the Third Municipal District, bounded by Saint Bernard Avenue, Marais Street, Laharpe Street, North Villere Street, and Columbus Street.
