- 1. **Re-Consideration:** [21-1366] A request by N. Robertson Artist Studios for the potential sale or long term lease of a portion of N. Robertson Street between St. Ferdinand and Press Street (Unconstructed)/ the Railroad (The Great Alabama Southern R.R./ Norfolk Southern), in the Third Municipal District. (Previously on agenda for PAC of 3/4/20 and 9/)
- 2. **Consideration**: [21-1362] A request by Sharif K. Sakla for the potential sale or long term lease of a portion of Colapissa St. that runs from Burdette St. to Fern St., located in the Seventh Municipal District, Square 463, adjacent to Municipal Address 7818 Earhart.
