

NOTICE OF INTENT TO REQUEST RELEASE OF FUNDS

On or about October 23, 2024 the City of New Orleans Office of Community Development on behalf of the Housing Authority of New Orleans will submit a request to the U S Department of Housing and Urban Development for the release of Public Housing Capital funds under Section 9 of the United States Housing Act of 1937 (the 1937 Act), which created the CFP as part of the Quality Housing and Work Responsibility Act of 1998 (title V, Pub. L. 105–276, approved October 21, 1998) as amended, to undertake a project known as “HANO Repairs and Maintenance” for the purpose of maintenance work on the HANO Headquarters buildings at 4100 Touro Street, New Orleans, LA 70122. Work items include roof replacement on Bldg. B, non-emergency repairs to the building at 4100 Touro to remove selective drywall, patch and paint to match existing based on water intrusion report for Bldgs A&B; Install additional roof drains as needed for Bldg B; Power wash exterior of Bldgs A&B; Reglaze (or replace) windows Bldgs A&B; Remove caulk and re-caulk all windows and doors Bldgs A&B; Remove deteriorated caulk/sealant at perimeter metal flashing and reseal all metal flashing Bldg B. The project will use \$900,000.00 of capital funds under grant numbers as follows: LA48P001501-19 (\$75,000.00); LA48P001501-23 (\$325,000.00), LA48P001501-24 (\$500,000.00). The estimated cost of the maintenance and repairs is approximately \$2,200,000.00.

The activities proposed are categorically excluded under HUD regulations at 24 CFR Part 58 from National Environmental Policy Act (NEPA). An Environmental Review Record (ERR) that documents the environmental determinations for this project is on file at City of New Orleans Office of Community Development, 1340 Poydras Street, 10th floor, New Orleans, Louisiana 70112. The ERR can be examined by contacting the Environmental Compliance Office, Craig Foundas, Director of Environmental Compliance, Room 917 in the same building weekdays from 9A.M to 4P.M.

PUBLIC COMMENTS

Any individual, group, or agency may submit written comments on the ERR to the City of New Orleans Office of Community Development, Environmental Compliance Unit, 1340 Poydras Street, 10th Floor, New Orleans, Louisiana 70112. All comments received by October 22, 2024, will be considered by the City of New Orleans prior to authorizing submission of a request for release of funds.

ENVIRONMENTAL CERTIFICATION

The City of New Orleans Office of Community Development certifies to the U S Department of Housing and Urban Development that Tyra Johnson Brown in her capacity as Director of the Office Housing Policy and Community Development consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD’s approval of the

certification satisfies its responsibilities under NEPA and related laws and authorities and allows the City of New Orleans to use Program funds.

OBJECTIONS TO RELEASE OF FUNDS

HUD will accept objections to its release of fund and the City of New Orleans certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the City of New Orleans; (b) the City of New Orleans has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to:
